

# DRUGS AND COSMETICS (8TH AMENDMENT) RULES, 2005

## NOTIFICATION

New Delhi, the 21st December, 2005

**\*G.S.R. 735(E).**— Whereas a draft of certain rules further to amend the Drugs and Cosmetics Rules, 1945 was published, as required by Sections 12 and 33 of the Drugs and Cosmetics Act, 1940 (23 of 1940), in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i) dated the 2nd February, 2005, under the notification of the Government of India in the Ministry of Health and Family Welfare (Department of Health), number G.S.R. 51(E), dated the 2nd February, 2005, inviting objections and suggestions from all persons likely to be affected thereby, before the expiry of a period of forty-five days from the date on which copies of the Official Gazette containing the said notification were made available to the public;

And whereas copies of the said Gazette were made available to the public on 3-2-2005;

And whereas no objection or suggestion was received from the public on the said draft rules;

Now, therefore, in exercise of the powers conferred by Sections 12 and 33 of the said Act, the Central Government, after consultation with the Drugs Technical Advisory Board, hereby makes the following rules further to amend the Drugs and Cosmetics Rules, 1945, namely:—

1. (1) These rules may be called The **Drugs and Cosmetics (8th Amendment) Rules, 2005.**  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In The Drugs and Cosmetics Rules, 1945, in the Schedule O, for Part I following shall be substituted, namely:—

### “Part I

#### PROVISIONS APPLICABLE TO BLACK FLUIDS AND WHITE FLUIDS

The standards for disinfectants shall conform to the Indian Standards specification (IS 1061:1997) laid down from time to time by the Bureau of Indian Standards.”
