**Subject :**Allowing all NEET PG aspirants medical graduates to appear in stray round as well as State counseling – Without cutoff.

This is to request you to kindly permit all candidates who have appeared in the NEET PG 2020 Examination to participate in the remaining counseling i.e. MOP up counseling and stray vacancy round without any cut off constraints. These candidates have otherwise passed their graduation and thus fulfill the basic eligibility criteria.

Inspite of the lowered cut out the Post Graduates seats in various medical colleges of the institutions have remained unfilled. It is prudent and wise to evoke prompt modalities so as to ensure that the precious Post Graduate seats in medical colleges as avenues on higher medical education do not go vacant.

Further in terms of the Orders by the Hon'ble Supreme Court, the last date for making admission to Post Graduate courses has been altered to 31st August 2020 in place of 31st July 2020 and the communication to that effect has been issued for the information of all concerned by Board of Governors in supersession of Medical Council of India through its Secretary in terms of a letter dt. 28th July, 2020.

It is for this reason; it is earnestly communicated to your goodself that all those PG NEET qualified students, independent of any "cut out" be declared as eligible for admission to Post Graduates courses against the vacant seats in such a manner that all the seats which are included in the matric and academic sessions 2020-2021 are filled in maximally.

The best utility of grant of extension of time by the Hon'ble Supreme Court upto 31st August 2020 stands best utilized by invocation of the said modality which would be in public as well as academic interest as well.
