Subject: Central Pool MBBS and BDS seats-Allocation for 2025-26 session- reg.

The undersigned is directed to forward herewith a statement indicating the number of MBBS seats alongwith the Medical College concerned, allocated for the academic session 2025-26 from the Central Pool for the Ministry of Education.

2. The admission of candidate to the medical college will depend on his/her fulfilling the eligibility criteria and other conditions of admission as laid down by the concerned State Govt. which may be ascertained from the concerned colleges.

3. The selection of eligible candidate will be made as per guidelines conveyed vide this Ministry's letter of even number dated 28th July, 2025 (copy enclosed). The copy of the merit list together with copies of allotment letter may be sent to this Ministry. Any complaints/grievances with regard to selection of candidate may be redressed in a time bound manner.

4. The selected candidate may be advised to report to the concerned college for admission well in time i.e. before the closing of admission and an intimation regarding his/her actual admission alongwith full particulars including his/her marks and the category to which he/she belongs, be sent to this Department within seven days of their admission.

5. It should be ensured that the selected candidate carries duly attested documents including his/her photographs when reporting for admission.

6. If the allocated seat is not utilized, the same may be surrendered to this Ministry before two weeks from the last date of admission, as notified by NMC/Dte.GHS.

7. In case, the seat remains un-utilized and this Ministry is not informed forthwith, this Ministry may have no choice but to stop the allotment of seats in the succeeding years.
