### IAP Election 2025 for the year 2026

#### 1. Introduction

Indian Academy of Pediatrics (IAP), a premier professional association of pediatricians in India, invites sealed proposals from qualified and reputed third-party auditing firms for the purpose of auditing its online election process. The goal is to ensure a secure, transparent, fair, and unbiased election that upholds the integrity and reputation of the organization.

#### 2. Objectives of the Audit

To assess the integrity, security, and transparency of the eVoting system.

To submit a comprehensive audit report certifying the fairness and validity of the election process.

#### 3. Scope of Work

The appointed auditor shall be responsible for the following:

##### Pre-Election Audit:

Audit of the eVoting platform provider's technical setup.

Security audit of the eVoting system, including encryption protocols, data integrity, and access control mechanisms. System dry-run and vulnerability checks (if permitted by the eVoting vendor).

##### Post-Election:

Audit logs of the voting system.

Match vote counts and results with backend logs and reports.

Ensure and confirm no Unauthorized access was there during election process

#### 4. Eligibility Criteria

The auditing agency must:

The auditing firm must be empaneled with CERT-In

Be a registered firm/entity in India with a minimum of 3 years of experience in IT audits, digital forensics, or election audits.

Have prior experience in auditing online election systems, preferably for professional bodies or statutory organizations.

## **5. Deliverables**

Signed Non-Disclosure Agreement (NDA)  
Audit Methodology Document (before election)  
Interim Report (if required) and within 24 hrs after declaration election result  
Final Election Audit Report within 7 working days of election closure  
Certificate of Compliance and Fairness

## **6. Proposal Submission Guidelines**

Firms are requested to submit their proposals in two parts:

### **A. Technical Proposal (in PDF format)**

Company Profile and Registration  
List of Key Personnel (with qualifications)  
Relevant Experience in Election Audits  
Audit Methodology and Tools Proposed  
Copy of Certifications (CISA, DISA, etc.)

### **B. Financial Proposal (separate PDF or sealed envelope)**

Fixed fee for end-to-end audit  
Any optional/additional service charges (if applicable)  
Applicable taxes

The auditor must maintain strict confidentiality of all data and processes.  
All reports and audit data shall be the sole property of IAP.
