Subjects	Examiners
<b>Medical Surgical Nursing</b>	Nursing faculty member with <b>M.Sc. Nursing in Medical Surgical Nursing</b> speciality with minimum 3 years of teaching experience for the concerned programme.
<b>Child Health Nursing</b>	Nursing faculty member with <b>M.Sc. Nursing in Child Health Nursing</b> speciality with minimum 3 years of teaching experience for the concerned programme.
<b>Community Health Nursing</b>	Nursing faculty member with <b>M.Sc. Nursing in Community Health Nursing</b> speciality with minimum 3 years of teaching experience for the concerned programme.
<b>Obstetrical &amp; Gynaecological Nursing</b>	Nursing faculty member with <b>M.Sc. Nursing in Obstetrical &amp; Gynaecological Nursing</b> speciality with minimum 3 years of teaching experience for the concerned programme.
<b>Mental Health Nursing</b>	Nursing faculty member with <b>M.Sc. Nursing in Mental Health Nursing</b> speciality with minimum 3 years of teaching experience for the concerned programme.

II. Universities / Examining bodies are to follow the regulations prescribed by this council in letter and spirit. Failure on part of universities in appointing examiners without following the above regulations prescribed by this council will have very serious ramifications and for which the concerned university / Examining bodies shall be solely responsible.

III. Universities included in Schedule II of Indian Nursing council as examining bodies are hereby intimated to regularly forward the following in order to remain in Schedule II as approved examining bodies:

- Constitution of Board of Studies in Nursing (UG & PG),
- Schedule of Examinations (Theory & Practical) for all Nursing Programmes.
