Minutes of the 71 st Annual General Body Meeting (AGBM) of the Indian Society of Anaesthesiologist (ISA) held under the Chairmanship of ISA President Dr J. V. Divatia on Saturday 23rd and 24th November 2024 at 2:00PM in Hall A during 71st ISACON 2024, Patna.

Welcome address: Dr. Sukhminder Jit Singh Bajwa, Hon. Secretary

Dr. Bajwa welcomed the ISA members to the 71st AGBM of ISA and requested everyone who is not a member of ISA to kindly leave the Hall. He then requested the ISA President to call the meeting to order.

Action taken Report of AGBM 2023 And Honorary Secretary's Report

Honorary Secretary's Briefing and Action

Taken Report.

I am pleased to present before you the Secretary's report from 27th November, 2023 onwards. The report has the following important ISA events and activities:

The following ISA programs and events took place after 27th November.

1. As there were many concerns and few grievances of ISA members with COVER You company regarding professional indemnity and health insurance, a National webinar was conducted on 21st December where all the COVER You officials interacted directly with the ISA members. The webinar was very constructive and fruitful and all ISA members gave their opinion on how to improve the services further. All these were noted down by the COVER YOU officials and they promised to do the needful at the earliest. Over the last 3 months, their performance had been satisfactory and the MoU was resigned with them on 15th March again after watching their performance and handling of any grievances matter.
2. **5Responsibility was given to one firm for the complete survey and enquiries about the properties in the Delhi & NCR as per the decision taken in the AGBM 2023 at Gurugram. A very exhaustive search and survey was done and the report submitted is attached as **Annexure-1 & 2.****

3. An ISA sponsored national workshop on mechanical ventilation was conducted at Jodhpur along the members of Jodhpur City Branch and Rajasthan State Branch on 21st January, 2024. This workshop was monitored by ISA GC member Dr. Sunil Sethi as the National Coordinator.



4. ISA Registered Office

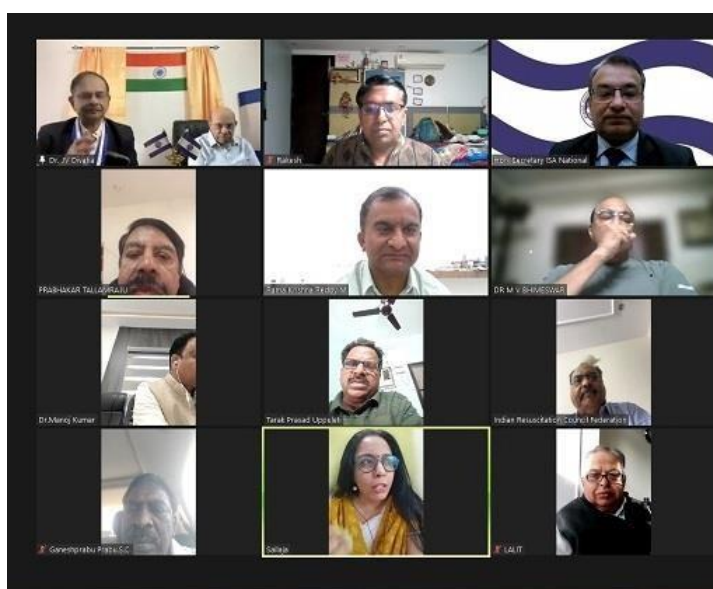

6. Scientific committee meeting for the ISACON-2024 was held at Patna from 3rd Feb-4th Feb. It was attended by ISA President Dr. J.V. Divatia, Academic Chairman and Past President Dr. Bhimeshwar M.V. President Elect, Dr. Balavenkat Subramanian, Hon. Secretary Dr. Sukhminder Jit Singh Bajwa, Hon. Treasurer & National Coordinator ISACON 2024 Dr. Manoj Kumar, EIC IJA Dr. Rakesh Garg, GC Member Dr. Rekha Das. The organising committee as well as

scientific committee members discussed the various scientific aspects and conference logistics during these two days of the meeting and a very meticulous skeletal structuring of entire scientific program was made with consensus.



7. On 10th February, at Jaipur along with ISA officials of Rajasthan and Jaipur Society of Anaesthesiologists, Hon. Secretary (representing ISA National) felicitated Dr. Maya Tandon at her residence in Jaipur. 9. A sum of Rs. 9,013,41.72 was paid as subscription fees to WFSA on 20th Feb, 2024 and that too second time in the same financial year. This does not include CA and accountant fees. It was essential as more than 300 hundred delegates from India were attending the conference, and no WFSA official could have conveyed in the General Assembly that India is in the list of nonpayment of subscription fees.

11. On 25th Feb, 2024 formal installation of ISA Loni City branch was done along with conduct of a CME. The occasion was graced by President ISA National and GC Members Dr. Indrani Hemantkumar and Dr. Chandrasekharan Cham along with ISA Maharashtra State ISA officials.



12. WCA at Singapore from 3rd to 7th March was attended by huge representations from India. A record number of poster and paper presentation was done from

Indian delegates besides many excellent talks delivered by the renowned faculty from our nation. A record of 78 recommendations was made for the WFSA scholarship for WCA out of which 4 got the scholarship. Besides that many of the posters and papers won the positions in their respective categories. ISA POD at Global Village became very popular with the ISA members and few members from different societies. It was beautifully designed by the ISA NHQ graphics team. All the poster presentations will be published in the March issue of Vapour.

Most importantly, Dr. Balavenkat Subramanian was elected as the Secretary of WFSA on 3rd March and big congratulations to him.



13. Non Academic functions being celebrated by ISA National

On 10th March, ISA National celebrated International Women's Day. The highlight of the event was that the first time all four Lady ISA Past Presidents were involved in the national

activity on the ISA Online platform. Somehow, at the last moment due to health issues Dr. Premlatha could not join. 14. From 12th to 16th March, ISA Sponsored National PG Assembly was conducted at Lucknow in the presence of ISA National Coordinator Dr. R.K. Bhasker. As per the reports and feedback, it was wonderfully done and attended by almost 300 delegates and faculty members

16. From 23rd to 24th March, ISA Manipur State conference was conducted. Dr. J.V. Divatia attended the conference on behalf of ISA National.

17. Academic programs, proposals and requests from various ISA branches.

Majority of the approved academic proposals for CMEs and Workshops of the previous cycle (1st April, 2023 to 31st March, 2024) have been conducted. Few of them were postponed due to various issues and requests have been received to carry out those in this year.

Besides these, we are planning to launch the Undergraduate Classes for Anaesthesia which will definitely highlight the efforts of the National GC in making a uniform curriculum of Anaesthesia for the UG in line with the efforts of bringing uniformity in PG curriculum also.

- 18. The detailed list of ISA Members of each state is sent to all the Presidents and Secretaries of the state branches. It is always their prerogative to update the lists along with the help of city ISA officials and other ISA members of their respective states.**
- 19. Majority of nonacademic activities are also being carried out regularly. ISA National heartily congratulates all the Program Heads and coordinators of these activities.**
- 20. World SIVA was discussed with Dr. G.D. Puri again after AGBM 2023. It was conveyed to him during earlier meeting as well as after AGBM that it cannot be held in 2024. He requested that since his entire team is at Chandigarh, it will be easy for him to conduct this conference from Chandigarh as his liaisons with local ISA Members and sponsoring agencies are good. Moreover, Hon. Secretary will be the organising secretary and ISA National Treasurer will be the organising treasurer and it will be easy for them also to function and travel to Chandigarh during preparations.**
21. An online meeting was held during the mid-May between the IMA and the executives of almost every specialty. The main theme of the meeting was preventing spread of anti-microbial resistance and to put a combined front for various medicolegal problems and SOPs on Patient Consent when it comes to representation at National Level. Dr. Divatia, President ISA National and Dr. Sukhminder Bajwa attended the same. The proposals are attached as **Annexure-6.**

22. All the ISA sponsored CME's, Workshops and PG assemblies are now being held under the aegis of CISA. The logo of ISA and CISA are made compulsory for all such events. As per the decision taken in the 1st Midterm meeting, every city and state branch now has to take approval to use logo of ISA if they are going to collaborate with any other society or organisation for any academic or non academic event.

Various committees were formed to look after the ISACON 2024 work. GC members were made the national coordinators/supervisors of all such committees and to ensure the smooth working and progress of these committees is the responsibility of all respective GC members.

ISA PPF advisories were sent for the peer review and comments from 5 reviewers were sent to Dr. Pankaj Gupta for the necessary revisions.

An online Zoom meeting was held on 07/08/2024 to kick start the simulation program across India which was attended by current GC members and many heads of the simulation centres. As per the decisions taken in the committee, a draft of MoU was formulated which was sent for the legal opinion. The legal report of the MoU draft was received on 11th August and minor essential changes were done to start the program.

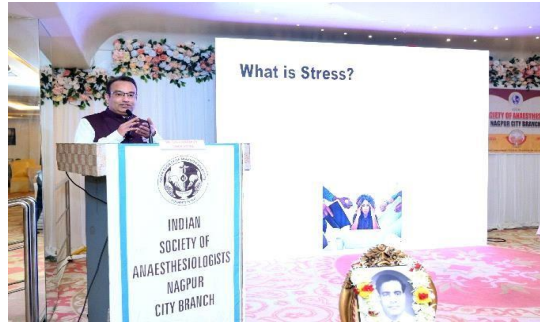

ISA Visakhapatnam city branch and Gayatri vidya parishad medical college organised Hands-On workshop on " TIVA and TCI".



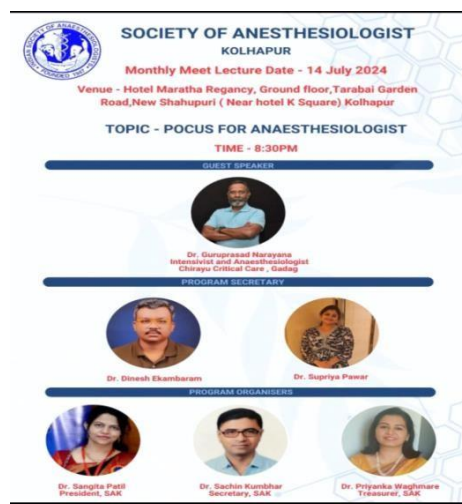
48. 13th and 14th July 2024

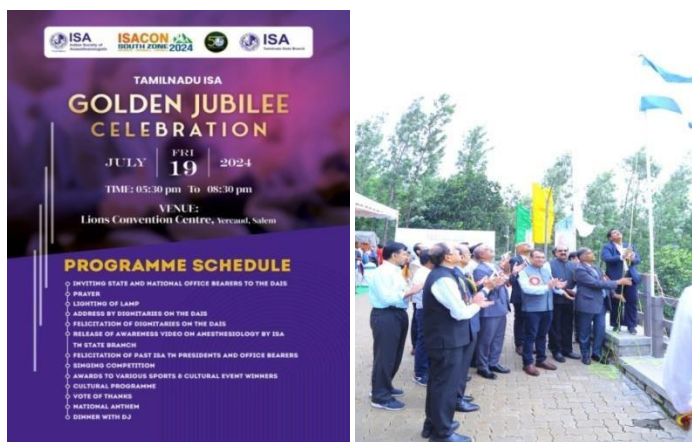
49. 14th July 2024

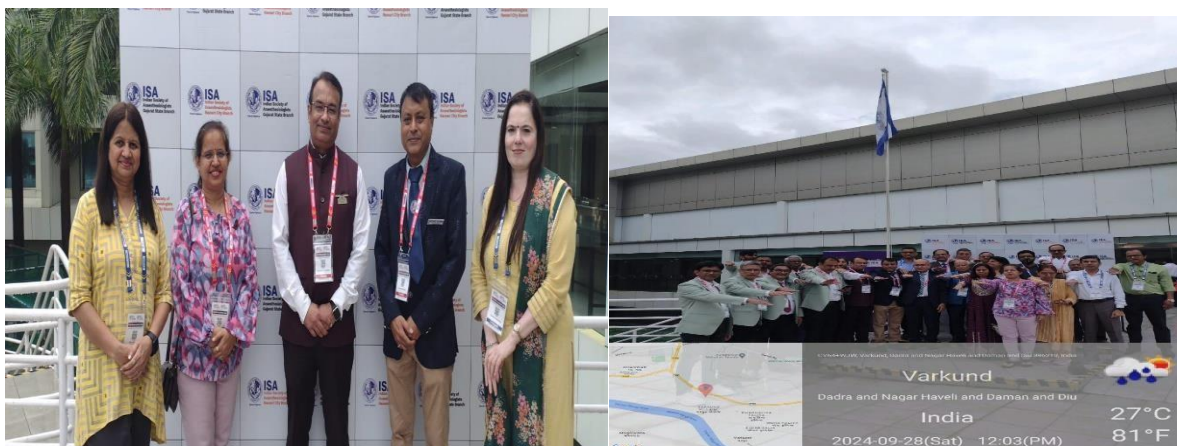

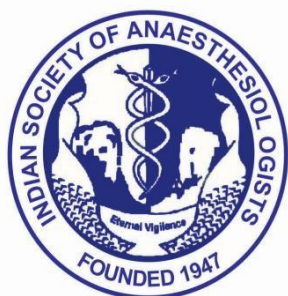

Minutes of Special AGBM held on Saturday, 16 August 2024, at Hotel Clark's Inn, PNM Mall, Patna

Organising chairman of ISACON 2024 Dr Gautam Saha welcomed all for this special AGBM held on 16th August 2024 at Patna.

The meeting was called to order by President Dr. Divatia, Vice President Dr. Ganesh Prabu, president-elect Dr. Balavenkat, Hon Secretary Dr. Sukhminder Jit Singh Bajwa, and Treasurer Dr. Manoj Kumar.

As the quorum to conduct the meeting was inadequate, the meeting was adjourned for 30 minutes and the meeting took place in the same auditorium after 30 minutes. The President asked the Honorary Secretary to proceed.

Hon. Secretary welcomed the members to the special AGBM. AGENDA FOR CONSIDERATION/DISCUSSION

AGBM-16/24:Treasurer's Report and Budget

The ISA National Treasurer, Dr Manoj Kumar, presented the treasurer's report and budget for the year 2024–2025.

During the discussion, Dr. Bajwa informed the house that ISA wishes to bid at the World Congress in the year 2030. For that, we need to increase our membership at WFSA.

Dr. Balavenkat informed the house that in the year 2026 WCA will be held in Morocco, followed by Vancouver, Canada in the year 2028. In the year 2030, it will be the turn of Southeast Asia. Applications have to be sent earlier before the Morocco conference. China, Japan and South Korea are in competition. We may get the conference if we have our membership no. above the membership no of Japan. Current fees per member are \$4 per annum. We need to have a membership number of around 9500 to 10000. The amount comes to 450 rupees per annum per person. Our image at WFSA, with less membership, is like a country of the Sub-Saharan region. In spite of phenomenal growth, it is painful to listen to such comments when one sits there. If our membership number is increased, the possibility of getting WCA in 2030 to India is enhanced.

Dr B Radhakrishnan said that he is deeply concerned about what Dr.Balvenkat is saying. But to have 10000 active members at WFSA, we will need to pay an additional 39 lakhs every year. What additional benefit is ISA going to get? He advised to increase the membership number slowly.

Dr. Bajwa mentioned that it is a question of pride and self-esteem. We have to bid by May 2025.

Dr Chakrarao mentioned that we need to find out the benefit which we will be getting. We do not have yearly membership fees. Every year how are we going to raise the amount? We cannot escape GST. We have to abide by Indian law. We are not getting enough money from ISACON. Corpus is important. We need to think judiciously.

Dr Divatia informed the house that we needed to raise funds. He further said that he has two to three solutions to avoid bankruptcy. From the new membership, some amount can be given for WFSA amount. Some amount can be generated from the State president and secretaries. This was discussed with them in their meeting. They were cooperative and were ready to give 500 rupees per delegate from the conference money to the WFSA fund. There is a risk, but we have a plan, and we think that the plan will work. We can generate more money from our conference. Why are we discussing this urgently is because all of us are eager to host WFSA 2030.

Dr Giri suggested increasing financial liability by 10% every year. He mentioned that we could take amount of 500 rupees from each new member.

Dr B Radhakrishnan suggested not going ahead as we cannot eat from our reserve.

Dr Divatia said, "We have the ability to raise money." So should we not go ahead? It is possible to sustain this amount. The urgency is to bid for WFSA.

Dr Balavenkat mentioned, this is a lot of emotional state. We are raising the issue of truth straight from the heart.

Dr. Sudarshan Kasturi raised the issue of not getting ISA shares in spite of sending branch reports and audited account reports. Dr Bajwa answered his query by asking him to send reports and details again.

Dr. Giri said we can definitely reduce some expenses in ISA.

Dr. Balabhaskar was also of the opinion of increasing the membership of WFSA. He mentioned that if state and city branches contribute, this may be possible.

Dr Naveen Malhotra said our membership has increased over the last 4 to 5 years. He further said that the amount calculated comes to 40 lakhs and not 60 lacs.

Dr. Pradeep Sharma inquired about the election process of WFSA.

Dr Divatia concluded that we can easily pay for additional expenses if we have the means to do it.

The Treasurer's Report was proposed by Dr R.Bhaskar and seconded by Dr Sujata Ghosh, Dr Bande, Dr Lalit Raigar and Dr Rajiv Gupta.

AGBM-17/24:IJA/SAARC/PEAK-Editor's Report

Editor-in-chief, Dr. Rakesh Garg presented the IJA report as well as his future strategies for IJA in the coming year. He thanked the authors, reviewers and the editorial team for their hard work.

The AGBM decided to decrease the print-out copies of IJA to 500.

Dr. Arun Mehra inquired and asked why not stop printing copies all together.

Dr Harsoor suggested that we might take charges for article processing at least from non-ISA members. Dr. Rakesh Garg said that he will explore the possibilities.

Dr Vijayanand mentioned that IJA is not helping with the publication to which Dr. Garg explained about the introduction of the new journal of ISA 'PEAK' as well as the merits of articles published in IJA.

Dr. Tichkule inquired about the status of library subscriptions. Dr Balabhaskar asked for a 10% increase in subscription charges.

This agenda was proposed by Dr Balit Singh and Dr Kameshwar Rao and seconded by Dr Rashesh Diwan and Dr Bande.

AGBM-18/24:ISACON 2022

Dr Bajwa informed the house that the ISACON 2022 team was called for an online meeting during the 2nd Midterm GC meeting of ISA National. It was conveyed to Dr. Diganta Das, organizing secretary ISACON 2022, to submit the audited reports as well as the MoU with the various pharmaceutical companies to proceed forward. Dr. Diganta Das had asked for some time to complete all these things.

This agenda was proposed by Dr Kameshwar Rao and seconded by Dr Baljit Singh.

AGBM-19/24:ISACON 2023

Dr Bajwa informed the house that the Organizing team for ISACON 2024 has already returned the loan of Rs. 10 Lakh and total Rs. 20 Lakh as had been mentioned in the MoU. Apart from that, ISA Haryana has also deposited sum of Rs. 5 Lakh for the best Lady Anesthesiologist of India award for which criteria is being finalized, and the award will start from ISACON 2025 and onwards. The team has also submitted their audited accounts of the conference.

Dr Mahesh Sinha asked for the presentation of audited accounts to the general body. This agenda was proposed by Dr Bharat Bhushan and seconded by Dr Rajiv Gupta.

AGBM-20/24:ISACON 2025

Dr Bajwa informed the house that the ISACON 2025 team had presented a report to the governing council. The scientific meeting is planned on 11th and 12th January. The registration charges have been increased by 18% to that of Patna, which will be applicable after the Patna conference.

This agenda was proposed by Dr Rajeev Gupta and seconded by Dr Bharat Bhushan and Dr Chakra Rao.

AGBM-21/24:ISACON 2026

Dr. Divatia informed the house that depending upon the received applications from the city of Coimbatore and Trivandrum and depending on constitutional protocols, the Governing Council has decided on Trivandrum as the place to conduct ISACON 2026.

The agenda was proposed by Dr Mahesh Sinha and seconded by Dr Arun Mehra and Dr Muralidhar Joshi.

AGBM-22/24:Proposal of Amendments/Modifications in Constitution and the Rule Book

Comprehensive modifications, suggestions and additions to the many clauses of the constitution and rule book have been worked upon by the governing council. They all were presented to AGBM and accepted by the general body. There was discussion about punitive action, which was accepted by the general body. This agenda was proposed by Dr Chakra Rao and seconded by Dr Kameshwar Rao.

There was a discussion regarding a hike in fees for habitual repeaters contesting the election. However, it was not accepted by the house.

The following are the comprehensive amendments which have been passed by the AGBM:

ARTICLE - V TERMINATION / CESSATION OF MEMBERSHIP

Membership from the society shall cease by:

Voluntary resignation by the member A member may resign in writing to honorary Secretary. The GC shall accept the resignation unless recovery is due or disciplinary action is pending against the member.

Disciplinary action

The GC may recommend by a two-thirds majority disciplinary action against any member for any proven disregard or violation of the rules and regulations of the ISA, unprofessional, abusive or violent behaviour during meetings, conferences or elections of the ISA verbally, in writing or on any social media platforms at the city, state or national levels, criminal misconduct or conviction in a criminal case, or action prejudicial to the interest of the Society at large. The GC may take suo moto cognizance of such offences or act on written complaints supported by documentary or other physical evidence made to the GC by any member of the ISA or the public at large.

Any complaint without supportive documents and evidence will not be considered, and the complaint shared on social media will not be considered. The complainant/s has to wait for the decision of the GC. Until that time, if the complaint is circulated on social media, the complainant/s and the persons sharing such complaints on social media will be liable for disciplinary action.

The accused member will be served a notice in writing to appear in the next meeting of the GC(physical or virtual) and will be given an opportunity to explain his/her conduct. The GC may take Disciplinary action depending on the seriousness of the offence and may range from

A.Reprimand;

B.Suspension from membership of the ISA for a period of 1 week to 1 year. This suspension period, if confirmed at the next AGBM, will result in a break in continuous membership of the ISA.

C.Temporary suspension or dismissal from any post held in the national, state or city branch GCs in case of members of such GCs. This suspension period, if confirmed at the next AGBM, will result in a break in continuous membership of the said GC

D.Debarring the member from contesting elections in any formation of the ISA for a period varying from 1 year to permanent debarment

E. Termination of membership of the ISA

The disciplinary actions listed above must be presented for endorsement at the next AGBM. If the GC recommends suspending membership for such a member, it shall remain suspended until the AGBM ratifies the decision at the next meeting. The AGBM's decision will be final and binding on all concerned.

A member whose name has been removed from the society's membership list under the above clause may apply for membership after the term of suspension expires, provided his application is approved by a two-thirds majority of the GC and confirmed by the AGBM at its next meeting. The prior duration of membership will be deleted from the record.

ARTICLE – VII

ELECTIONS

All the elections of the society will be conducted by online voting only. Notification will be issued on 10th June every year. The schedule of

elections will be published by the Honorary Secretary in consultation with the Chief Election Officer in June every year as per the Election Calendar in Annexure III.

Elections will be conducted from the Administrative Office of ISA, and the CEO or his nominee will perform them.

No member can hold two posts in any formation: National, Zone, State and City.

The President-Elect shall hold office until the end of the next AGBM, at which he/she will be installed as the President. The President-Elect must resign from the post held at any formation of the society. The tenure of the President shall be one year, at the end of which he shall become Immediate Past President. The President will not be eligible for election to any office in the society within or below the National formation (City/ State/ National). However, the Past President may be nominated for a post of coordinator or chairman of committee or any other post of importance where their services are needed.

The Vice-President: He/she shall hold the post of Vice President for one year. She/he shall not be eligible to contest for any post except the President-Elect. The past Vice-President will not be eligible for election to any office in the society within or below the national formation (City/ State/ National) except for the National President-Elect.

The Honorary Secretary, the Honorary Treasurer and the Editor-in-Chief, Indian Journal of Anaesthesia shall be elected by online voting as per the election notification. They shall hold office for 3 years, after which they shall not be eligible for re-election to the same post. Resignation or absence of one among them will not affect the membership of another member. Members of the GC will not be eligible for re-election for another term for the same post. Past Honorary Secretary is eligible to contest for the post of Vice President and President-Elect only. Past Honorary Treasurer can contest for the post of Secretary, Vice President and President-Elect only. Past Editor-in-Chief IJA can contest for all the posts except for IJA Editor-in-Chief and GC Member. GC Members will be elected by online voting. Unless specified, all Council Members shall hold office for 3 years, and they are not eligible to re-contest for the same post.

The Hon. Secretary shall notify the vacancies in the Governing Council to be filled at the forthcoming elections by 10th June each year through the ISA Website / Indian Journal of Anaesthesia / Newsletter.

Every nomination, together with the written consent of the candidate to contest the election, duly proposed and seconded by two valid life members should be sent to the Honorary Secretary by E-mail / Registered Post with acknowledgement due / Courier / Speed Post / By hand (Receipt to be obtained) so as to reach him/her by the 15th June each year. If the last date happens to be a holiday, then the next working day shall be considered as the last day. The proof of attending 3 out of the previous five regular AGBMs should be submitted by the contestant while submitting his nomination papers duly notifying the serial number in the AGBM register, which shall be available on the official website of our Society. For every post to the GC (the President-Elect, the Vice President, the Secretary, the Treasurer, the Editor in Chief of IJA, GC Member), the nomination must be accompanied by the designated non-refundable nomination fee in the form of the receipt – a self-attested counterfoil of bank transaction statement, of successful payment via NEFT, favouring “ISA National” payable at the city of the Secretary's office. The nomination paper not accompanied by the receipt- self-attested counterfoil of bank transaction statement, for the NEFT of Nomination Fee, will be deemed invalid. A curriculum vitae (CV) of the contesting candidate not exceeding 250 words may accompany the nomination and will be circulated to all eligible members through society media. Excess of CV beyond the first 250 words shall be deleted.

Nomination fees are fixed as below:

President-Elect: A sum of Rs. 30,000/- (Rupees Thirty thousand only)

Vice President: A sum of Rs. 20,000/- (Rupees Twenty thousand only)

Secretary*: A sum of Rs. 30,000/- (Rupees Thirty thousand only)

Treasurer*: A sum of Rs. 30,000/- (Rupees Thirty thousand only)

Editor-in-Chief : A sum of Rs. 30,000/- (Rupees Thirty thousand only)

GC Member: A sum of Rs.20,000/-(Rupees Twenty thousand only)

(*The nominee for the post of the Secretary and the nominee for the post of the Treasurer shall submit separate applications and shall also pay the fixed nomination fees individually.)

Candidates contesting for any post in the National GC or State GC, as well as city branch President and Secretary, must be approved members of the ISA Family Benevolent Fund (FBF) at the time of filing their nominations for the elections. It is highly desirable that other executive members of the city branch should also be FBF members.

ADDITIONAL CRITERIA FOR CONTESTING FOR THE POST OF EDITOR-IN-CHIEF, IJA AND OTHER JOURNALS OF THE ISA / CISA

The applicant should possess at least 10 years of experience in Anaesthesiology and be a member of the ISA for at least 5 years.

Applicant should have at least 5 years of experience serving on the editorial board of a PubMed-indexed journal.

Must have a minimum of 15 original articles / systematic reviews/meta-analyses in PubMed-indexed anaesthesiology journals (other than Case reports, letters to the editor, short summaries, etc.) or a Google Scholar H-index ≥ 10

It is desirable that they should have contributed to a registered ethics committee as a member for at least two years.

Must have at least one Good Clinical Practice training certificate obtained prior to applying as a candidate for election for the post of EIC

A background in publishing, editing, or journalism is a must.

Each applicant should provide a summary of the vision document (200 words) outlining editorial strategies for development in the next 3 years to improve the quality of the journal further.

The CEO will verify all nominations along with election officers, and a preliminary list of contesting candidates will be notified at the ISA Office and on the ISA website on or before 5.00 p.m. on 16th June. The Chief Election Officer can avail the services of more members from GC to conduct elections. The members who have proposed or seconded the nomination of any candidate are not eligible to be in the conduct of the election process. After scrutiny, the list of all valid Nominations will be published on 18th June.

Nominations can be withdrawn (only by the candidate) in writing before the release of the list of valid candidates, that is, up to 5:00 PM on 21st June. If 21st June is a holiday, then the next working day will be taken into account. The final list of eligible candidates will be published in ISA Office and ISA website on 22-06-2025. In the absence of any valid nominations, as stated above, the General Body shall proceed to hold the election of the office bearers from amongst the eligible members present at AGBM.

GC members, other than the contestants, will not directly campaign through personal email, mobile, Facebook, Whatsapp, or other social, electronic, or print media.

8. If there is evidence that any GC members have violated the above campaign norms, they can be suspended temporarily from November 1-5 of that election year and not allowed to vote. This five-day break will result in his /her tenure in the GC being deemed incomplete.
9. Prospective candidates should not publicly declare their candidature in any meeting or group on social media, electronic media, or print media prior to June 10 of the election year.
10. Canvassing by the candidates themselves will be allowed on social and electronic media only from 10 June onwards until 25th June.

11. Any member who feels aggrieved by the content of any campaign material in any media may complain in writing, along with documentary proof, to the Chief Election Officer/Commission (CEC). If the CEC finds merit in the complaint, they will convene a meeting with the national GC to decide on the complaint. Suppose a majority of members at the convened GC meeting find that the campaign material is abusive, derogatory, defamatory, or potentially promoting hatred towards any group, community or gender or is found to be prejudicial to the interests and prestige of the ISA; In that case, disciplinary action will be taken against any member who has composed or forwarded such messages in any medium. Before any disciplinary action is taken, the accused member will be served a notice in writing to appear in the meeting of the GC and will be given an opportunity to explain his conduct. Disciplinary action may include one or more of the following:

- A. Reprimand
- B. Suspension from membership of the ISA for a period of 1 week to 1 year. This suspension period, if confirmed at the next AGBM, will result in a break in continuous membership of the ISA
- C. Temporary suspension or dismissal from any post held in the national, state or city branch GCs in case of members of such GCs. This suspension period, if confirmed at the next AGBM, will result in a break in continuous membership of the said GC
- D. Debarring the member from contesting elections in any formation of the ISA for a period varying from 1 year to permanent debarment
- E. Termination of membership of the ISA.

Penal actions listed above must be presented for endorsement at the next AGBM. The decision of the AGBM will be final and binding on all concerned.

Once a candidate has filed his/her nomination for election to any post, they should not attend any meeting/CME/PG assembly/webinar/other academic programmes as an invited faculty. They may participate as

ordinary delegates without any travel, registration or accommodation provided by the organisers.

Any member of the ISA national GC contesting the election should not be allowed to attend official meetings from 10th June to 30th June. Technical resignations from them should be accepted before election notification.

ELECTION DISPUTES

a) In the first instance, any complaint pertaining to any process of election must be lodged with the Chairperson/CEO of the Election Commission along with documentary proof of any irregularity before the start of the counting procedure. No complaint other than that of the counting procedure shall be entertained once the counting procedure has started. Complaints pertaining to the counting procedure or counting irregularities, if any, must be lodged in writing by the contestant or his representative with the Chairperson of the Election Commission during the counting procedure or immediately after the counting has been completed or within fifteen days after the completion of counting.

b) The Election Commission chairperson and members should view the election window prior to closure on the last day.

c) Election contestants can request to see the post-election voting pattern for their post at the office of the Secretary. This will be done through a written request and in the presence of at least one election commission member nominated for this process. The complainant will bear the cost of this.

d) An Election Redressal Committee comprising the President and two immediate Past Presidents would review the evidence provided by the complainant and would give its ruling within 15 days.

e) If the complainant remains unsatisfied with the decision of the Election Redressal Committee, they may ask for a hearing by a Review Panel.

- f) The Review Panel is composed of three past presidents who have not participated in the decision-making process in the Redressal Committee and two eminent members of the ISA (one nominated by the complainant and the other nominated by the ISA president) to find an amicable solution.
- g) The decision of the Review Panel shall be final and binding on all parties.
- h) The travel and accommodation expenses, as well as a daily allowance (to be determined by the GC) of the Review Panel, will be reviewed in arbitration if he loses the review. However, ISA will bear this cost if he wins. However, the candidate cannot claim any compensation whatsoever
- i) However, no candidate holding a stake in the election, either appellant or defendant, can claim any compensation or allowances related to any head during this redressal or review process.
- j) Once results are declared, they cannot be changed by any committee, including the election committee. It can be changed only following a decision by either a Redressal Committee or the Review Panel

ARTICLE - VIII

MEETINGS

GC

GENERAL BODY

The Honorary Secretary shall arrange to hold the Annual General Body Meeting (AGBM) every year at the time of the Annual Conference of the Society. This will be a hybrid physical onsite as well as a virtual meeting.

Additional General Body Meetings (GBMs) may be held in virtual mode within 45 days of the first and second Mid-term meetings of the ISA GC. The

procedure for the agenda and conduct of the meeting will be similar to that of the AGBM.

A special/Extraordinary GC meeting will be held once every year at the registered office of ISA Chennai. Each GC Member will be entitled to a maximum travelling allowance of Rs. 25000

ARTICLE-IX JOURNAL OF THE SOCIETY

ISA members have free online access to IJA. However, if the AGBM decides to charge for the hard copy, the members will have to pay a fixed price.

Till further orders or decisions, members have to register each year for a hard copy by sending an email or letter to the Editor-in-Chief requesting a hard copy of the journal. There will be an email subscription for hard copies of the IJA, which will be posted on the ISA website. Only 1000 hard copies will be distributed by email subscription on a first come, first served basis. Members who wish to have hard copies of the journal after the first 1000 print copies have to subscribe to the journal upon payment of the fees in force at that time. The details for the same shall be on the notice board of the ISA website.

The same applies to other journals that the ISA / CISA may publish from time to time, as mentioned in article 'College of the ISA'

ARTICLE - XIII CONFERENCE

The city branch that has been selected to host the National Annual Conference will enter into a contractual agreement with the ISA. This agreement will reflect the provisions of the constitution governing the conference conduct and accounts.

The agreement will be signed by the President and Secretary of the ISA on behalf of the ISA and by the (1) President of the city branch hosting the

conference, (2) Secretary of the city branch,(3) President of the State branch hosting the conference, (4) Secretary of the State branch hosting the conference, (5) Chairman of the Conference Organising Committee and (6) Organising Secretary of the Conference. The same individual must sign in their capacity, as the case may arise. This agreement will be signed by all the concerned signatories within one month of the date on which the conference is awarded to the city branch. It must be presented to the GC for ratification at the next GC meeting. In case of a change in the conference organising committee or city branch executive committee, the agreement will have to be signed again by the concerned persons.

12. All receipts in the name of the conference on any head whatsoever will be deposited in the central ISA account only. 80% of the amount received will be transferred to the account of the organising committee. However, all expenses incurred by the organising committee of the conference are subject to auditing and will have to be presented to GC within 6 months of completion of the conference and should be approved. GC, if so, can appoint its auditors to look into the conference accounts. It is advised that no wasteful expenditure is incurred in the organisation of the conference and maximum savings be made for the city branch also.

A sum of Rs. 500.00 shall be deducted from the delegate fee as dues towards affiliation of the ISA to the World Federation of Societies of Anaesthesiologists

ARTICLE-XV

BRANCH OF THE SOCIETY

A sum of Rs. 500.00 shall be deducted from the membership fee of new members to pay the ISA's affiliation dues to the World Federation of Societies of Anaesthesiologists.

AGBM-23/24: Progress of Academic College of ISA.

The College of Indian Society of Anaesthesiologists (CISA) was formally inaugurated during the anaesthesia week on 15th October. Its preliminary

structure was also conveyed to the ISA members along with its future functioning and working.

The agenda was proposed by Dr Bharat Bhushan and seconded by Dr Rajiv Gupta

AGBM-24/24 Revision of Private Practitioner's Forum Guidelines

PPF guidelines were again revised during this year and were robustly peer reviewed by the various renowned academicians and practitioners of our country and were released during the inauguration.

Agenda was proposed by Dr Mahesh Sinha and seconded by Dr choba.

AGBM-25/24: ISA National Elections/Introduction of new reforms/ special codes of conduct for ISA National Elections.

This year, it was decided in the GC to go to an external agency for the ISA National elections, 2024. The elections were conducted very smoothly and in a fair and transparent manner. Both pre-poll and post-poll auditing were done by another external agency like last year (KPMG). Considering the methodology of these elections, Hon. The secretary proposed to the house that always in the future, elections should be conducted by an external agency only. This will reduce the unnecessary burden on the secretariat.

It was further decided to give a three-week period from nomination to election. Dr Mahesh Sinha suggested that elections could be conducted earlier in the month of June or July. Dr B Radhakrishnan agreed with that. Dr Tanveer suggested that it should be combined with city and state elections. We should follow the policy of one nation, one election.

It was also decided that for zonal members the electorate should be pan-Indian. The whole country will vote for zonal members. Dr B Radhakrishnan mentioned that previously we did not get a lot of zonal representation.

Dr Naveen Malhotra said that we have modified the zonal reservation. There are 6 national governing council members and 6 zonal members, which can be selected through the national electorate.

Dr Bhimeshwar further said that anyone who has completed the criteria for nomination, but is still in the governing council, then a technical resignation is needed. So a technical resignation from a past Secretary, Treasurer and editor-in-chief is needed.

Dr. Naveen Malhotra mentioned that resignation is needed when you take the oath. However, Dr Bhimeshwar said resignation should be given at the time of nomination.

Dr Rajiv Gupta said that for the zonal governing council members there should be zonal elections. Dr. Naveen Malhotra mentioned that we need to discuss more on this agenda. As there are no seats vacant for zonal members in the upcoming elections, it can be discussed further. We definitely need to shorten the duration of elections. The selection of zonal members can be deferred until next year.

The AGBM decided to shorten the duration of elections to one month. The elections will be conducted anytime from 20 June 2025 to 20 July 2025.

There was a discussion regarding virtual AGBM. Dr. Divatia informed the house that twice a year, a virtual AGBM would be conducted.

This agenda was proposed by Dr Bharat Bhushan and was seconded by Dr Parul Jindal.

AGBM-26/24:FBF Matters/Elections

Dr. Sugu Varghese sent an official mail to the ISA NHQ highlighting the notification of FBF elections. FBF GBM was held on 22nd November from 4 PM onwards in Boardroom.

This agenda was proposed by Dr Baljit Singh and was seconded by Dr Chaobha

AGBM-27/24:New Financial instruments (as we have GST now)

Dr. Bajwa informed the house that since we have taken the GST number, now it is high time for society to go for the safe financial instruments to make the fiscal health of ISA healthier. The members are requested to voice their opinions on the viability of various financial instruments.

For the conference accounting, it was decided that ISANHQ will get the entire money in the ISANHQ account. 85% will be given to the organizers of ISACON and 15% will be retained by ISANHQ. This will start at the ISACON 2026 Trivandrum.

Dr Naveen Malhotra agreed that more money for ISA will definitely be useful for the welfare of ISA.

Dr. Sajeesh from Trivandrum mentioned that this proposal is an encroachment on the freedom of the organizing team. He said that he is skeptical of the proposal, and especially its implementation in Trivandrum. He said it will be an experiment on a small branch.

Dr BR Radhakrishnan also mentioned his unhappiness.

Dr Divatia convinced and reassured everyone.

The agenda was proposed by Dr Baljit Singh and seconded by Dr Rajiv Gupta, Dr Bande and Dr Bharat Bhushan.

AGBM-28/24: ISA Building in the NCR

Dr. Bajwa informed the house that the details of this project are listed in the annexure-1 & 2. The members are requested to voice their opinions on the initiation of this project, considering the financial health of society going forward.

He further said that he started looking for land in the NCR as he had formally committed to the last AGBM and a committee was also appointed.

In the future, we may need a building for CISA. If land is bought, it will never depreciate. The building constructed on the plot can be a permanent source of income. Multiple brainstorming is needed for this project. He requested GB to give formal permission and approval for this project.

Dr Divatia said that we already have an ISA house in Chennai, which is a two-bedroom flat. The GBM has to decide whether we want land in NCR.

Dr. Kameshwar Rao mentioned that the idea is good. He inquired about how much land was needed.

Dr BR Radhakrishnan said that we are a large society. The Chennai office will continue. But we definitely need a place in the Delhi NCR area. We can construct

it in a different way and as a different model. We can arrange programs for teaching and training. We can make the place economically viable.

Dr Bajwa informed the house that we had already planned a GC meeting for the month of June, on 7th and 8th in Chennai.

Dr Bajwa inquired the AGBM regarding the interest of the members as a part of the committee. A committee was formed which included Dr Radhakrishnan, Dr Baljit Singh, Dr Naveen Malhotra, Dr Manoj Kumar, Dr Bhadresh Shah, Dr. Deka, Dr Virendra Sharma. Dr Kuchela Babu suggested the name of the brig. Prabhakar and Dr Chakra Rao, who were also included in the committee.

Dr B Radhakrishnan said that NCR is a costly area. Noida is cheaper, so it can also be considered.

Dr Bajwa requested the AGBM for the reimbursement of travel expenses for the survey. This was passed for the first meeting in January and February. The committee is asked to present a report by 15th of March.

This agenda was proposed by Dr Tanveer Singh and seconded by Dr Baljit Singh and Dr Bharat Bhushan.

AGBM-29/24: WFSA Membership enhancement

AGBM-30/24:Dantrolene Matter

Dr. Bajwa informed the house that this matter had been followed intensely by the Governing Council. A survey was also done among the Indian Anesthesiologists. Efforts have already started to provide Dantrolene to almost every city at a very nominal rate to prevent the morbidity and mortality from Malignant Hyperthermia.

This agenda was accepted unanimously by the house.

AGBM-31/24: ISA Leadership Summit/Faculty development program

It was decided to implement this program from 2025. It was proposed by Dr Radhakrishnan and seconded by Dr Mahesh Sinha.

AGBM-32/24: ISA Simulation program visibility

This program has already kick-started during Anesthesia week in mid-October and currently efforts are being made to take this program to every part of the country after its first workshop in Pune on 13th October.

This agenda was proposed by Dr Anjali Bhure and seconded by Dr Anita Nehte.

AGBM-33/24 : ISA Haryana Award for best Lady Anaesthesiologist

The organizing team has given a sum of Rs. 5 Lakh to start this award for the Best Lady Anesthesiologist of India. The criteria for this award have already been finalized, and it will be given annually during ISACON 2025 onwards. Dr. Bajwa informed the house that the criteria would be more refined by next year.

This agenda was proposed by Dr. Parul Jindal and seconded by Dr. Tanvir

Dear Sir,

This is in response to the claim by the petitioner Mr. Rahil Chaudhary regarding the commercial exploitation of patients and using them as models to fulfill their ulterior motives through live surgery broadcasts in conferences. We, anaesthesiologists are closely associated with live surgeries done in workshops as a part of continuing medical education programmes and conferences. Many a times, we anaesthetise and take care of the patient who undergoes the live surgery. Hence, we wish to put forth our observations and views regarding this subject as follows-

- 1) Death and complications can occur during any surgery due to a variety of reasons, be it in a routine operation theatre or a live surgical workshop. Every stakeholder involved in a live surgery (the surgeon/ anaesthesiologist/ assisting nurse/ device manufacturing company representatives) will always make sure that the patient gets the best possible care. This is because he/she is very well aware of the fact that several people including subject experts will be watching the relayed procedure. Also, all the steps of the surgical procedure displayed during the live demonstration will be based on scientific and clinical evidence and the surgery will be done by reputed experts or meritorious luminaries in their respective fields. All this means that extra care will be showered on the patient like good food on a festival day and patient safety is further strengthened.
- 2) Newer knowledge and skills keep coming up. Every patient would want the latest skills and knowledge to be applied in his / her disease management. There exists a huge surgical population in India which is in need of continual education and up gradation of the existing knowledge and skills. The National Medical Commission (erstwhile, the Medical Council of India) has always stressed upon the fact that the Indian Medical Graduate has to be a self directed learner and this process of learning should continue throughout the graduate's professional career. In fact, every medical (surgical included) practitioner has to upgrade his/ her skills at par with the existing trends in the country, failing which, he /she cannot be allowed to renew his/ her registration and he cannot be considered safe to the patient. In this regard, pre-recorded surgical videos cannot serve the same purpose as a live relay.

Comparison with recorded videos or with artificial intelligence assisted simulators is like seeing a recorded cricket match without seeing the live match. In a live match, one can get a unique spirit of enthusiasm. Technology can make the view very different, especially the ball releasing and reaching the wicket keeper. The sound of the bat can be heard differently in a live match. Similarly, the surgical spirit and fine intricacies that one gets to see and experience in a live surgical workshop are unique. The feeling of directly seeing your favorite superstars on the field is similar to seeing the surgical celebrities operating in a live workshop. A live surgical workshop is a real life potpourri of newer surgical skills, knowledge, and application of novel technology and basic clinical acumen that helps everyone to better appreciate the subtleties and finer intricacies of the technique and skills and clear the doubts that are not possible in a recorded video.

- 3) Several patients who are poor/ cannot travel or afford to go to the higher surgical set-ups have benefitted from live surgical workshops because they get the benefit of the skilled surgery being done on their home turf without them and their relatives having to travel, stay and spend their hard -earned money in bigger cities.
- 4) Commercialization is inevitable in all spheres of life. If commercialization of equipment/ devices/ surgical material can be done in live workshops, it can be done in recorded videos too. We believe that there would not be much difference in the intensity of commercialization between the recorded and live versions.
- 5) Advances in computer, mechanical and other technology are leading to the constant pouring in of newer devices and equipment. The transfer of the knowledge of this new technology, the challenges and the newer techniques that emanate thereby becomes a huge necessity that cannot be neglected. Live surgical workshops help the attending surgeons to clarify their doubts regarding the technology and the procedure because the surgeons, anaesthesiologists and technology experts will all be gathered there under one roof.
- 6) India is now a hub for medical tourism and our healthcare sector is being envied by many and congratulated by all on the global arena. That means our surgeons are excellent and this surge towards more excellence has to continue. This would be possible only through continuous updating and upgrading of surgical skills. All this can be very well achieved in live surgical workshops. The feeling and confidence that one can gain by watching a live surgery cannot be paralleled by a recorded surgical video. Recorded videos appear artificial and unnatural. Indeed, in clinical practice, we have to deal with live patients and not with dolls/ cadavers.
- 7) The problem of dubbing of videos and use of artificial intelligence and video processing and video editing techniques to manipulate recorded videos is serious and this can lead to errors and inaccuracies in the videos and false claims by the person preparing the video. Also, erroneous interpretation of the observed videos is another cause for concern.

We reiterate that live surgeries are without doubt an excellent way to learn, are clinically useful and certainly do not compromise patient safety. We need to


continue with this teaching- learning method for the benefit of all our Indian surgeons and our surgical patient population. We would suggest that the National Medical Commission can be informed by the organizers of live workshops beforehand so that the commission can appoint an observer from its side who can attend physically/ virtually such workshops. These observers can provide their feedback to the commission regarding the conduct, usefulness, safety and credibility of live surgical workshops.

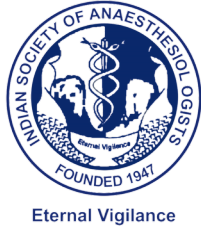

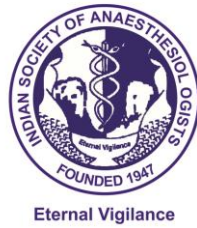

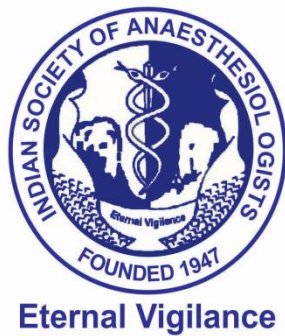

This initiative is facilitated by IML and is in its 11th year. Last year (2022) the first 'Global SOP on Patients Consent' was drafted and made public. The SOP as well as the sample consent forms are freely available on the portal.

- **National Convention on Medicine & Law** (www.medicinelawconvention.com)
An annual congregation of thought leaders in the healthcare domain. It discusses, debates, and deliberates on legal issues of national importance in healthcare. A white paper that is usually published is highly revered amongst policy makers and opinion formers. ISA has participated in this initiative twice.
- **Make Organ Donation Easy (MODE)**
The rate of organ donation in India is not very encouraging. Law and procedures are certainly required keeping in view the peculiar demography of the society. But minor changes in law and procedures can make a significant difference. This initiative aims to create public awareness on organ donation and also suggests and follows-up on legal changes that are required.
- **Patient Education Initiative**
At times, the patient or their attendants fail to understand their role in medical errors. They also carry a few wrong notions, which adversely affect patient care and treatment outcomes. IML has prepared some educational videos for patients and the general public aimed at ensuring patient safety. Judgments delivered by Indian courts in real cases are used as illustrations. IML intends to bring more interactive and informative offerings on patient education and patient safety and will need input and support from ISA.

An annual reference book on laws and legally correct protocols for doctors and hospitals. It helps them in keeping themselves updated. It is available only in print.
- **Medical Major Acts** (www.medicalmajoracts.com)
A digital repository of central laws directly applicable to healthcare. It is updated in real-time. A reference resource especially helpful for those in hospital administration.

Conclusion

An institutional collaboration between the two organizations is mutually beneficial and will help in ensuring and enhancing patient's safety and reducing medical errors.

Concept Note 'SOP on Patients Consent'

Doctor's to decide 'what is legal and valid consent' – Supreme Court

Patients consent is a legal requisite for every medical action. Law presumes consent of the patient in every doctor-patient interaction and also mandates that consent must be written if the consequences of any treatment or intervention are serious. Interestingly, consent is a purely procedural act and has little to do with medical science.

In India, the various aspects of consent are neither well defined nor comprehensively spelt out. Hence consent has emerged as the biggest problem for Indian doctors as far as cases of medical negligence are concerned.

The Supreme Court of India while delivering the landmark judgment on consent in the case of **Samira Kohli v/s Dr. Prabha Manchanda** has observed that **"The nature and extent of information to be furnished by the doctor to the patient to secure the consent should be of the extent which is accepted as normal and proper by a body of medical men skilled and experienced in the particular field."**

The legally correct and valid consent will therefore be the one that is considered correct and valid by the doctor community. The onus is on the doctors to discuss, decide, define, and prescribe the acceptable parameters of consent.

This Initiative

The 'SOP on Patient's Consent' is intended to be a standard, acceptable document on patients consent in India which is drafted, deliberated, and adopted by the doctors and the medical associations with inputs from prominent lawyers, editors of law journals, hospital administrators, health care activists, and consumer activists.

This exercise was initiated by the Institute of Medicine & Law in 2013 together with the national medical societies viz. IMA, FOGSI, ISA, ASI, API, prominent doctors, advocates, and editors of medical journals'.

Involving Doctors, Ensuring Transparency - The Legally Correct Approach

The Supreme Court has clearly observed that the medical fraternity will decide the acceptable standard on all medical issues. The active participation of doctors and medical associations in formulating this SOP ensures that it is considered by Indian courts as a well thought of, deliberated, organised effort of the medical fraternity and given due credence in legal proceedings.

Complete transparency is ensured at all stages. Comments of the 'Reviewers' are accessible on the website. This SOP is available on www.patientsconsent.com and can be viewed and downloaded absolutely free together with 4 different consent forms.

This complete exercise is conducted online without the necessity of physical presence of the 'Reviewers' and / or the members of the 'Approval Committee.' The customized software running this SOP ensures that the 'Reviewers' are able to post their comments online and the members of the 'Approval Committee' are able to view and deliberate on the various drafts of the SOP online.

Drafting the SOP – Step-by-step

1. IML invites participation from medical societies, editors of medical journals, eminent doctors, and others.
2. The previous years 'SOP on Patients Consent' is hosted online as the first draft of the current year SOP
3. The 'Reviewers' put their comments on each clause of the draft SOP. They also point out areas of disputes not covered in the draft SOP and pose questions that need to be answered or situations that need to be addressed.
4. The draft SOP is closed for the 'Reviewers' comments and thereafter this draft is made available to the 'Approval Committee' for their comments.
5. The 'Approval Committee' deliberates on the comments of the 'Reviewers' and makes the necessary amendments and finalizes the second draft SOP
6. The second draft SOP is then hosted online
7. The 'Reviewers' put their comments on the second draft SOP in the same way as comments were given to the first draft SOP.
8. The second draft SOP is closed for the comments of the 'Reviewers' and thereafter this draft is made available to the 'Approval Committee' for their comments.
9. The 'Approval Committee' again deliberates on the comments received from the 'Reviewers' and makes the necessary amendments and finalizes the SOP.
10. The Convenor approves and adopts the 'SOP on Patient's Consent' for that year

Greetings from Indian Society of Anaesthesiologists National Head Quarters !

Indian Society of Anaesthesiologists (ISA), the largest body of Anaesthesiologists in India with more than 39,000 members and 200 branches across India, represents clinical, academic and social issues pertaining to anaesthesiologists in India. The anaesthesiologists have worked dedicatedly in the critical care of COVID patients in critical care units in the ongoing COVID pandemic. Anaesthesiologists have dedicatedly managed intensive care units /critical care units since decades and treated critically ill patients efficiently. More than 70% doctors working in critical care units across the country are anaesthesiologists.

According to the revised pattern of the examination of NEET Super Speciality (NEET-SS), DM/DrNB in Critical Care Medicine (CCM) can be opted for by the candidates belonging to Anaesthesiology, General Medicine, Respiratory Medicine, Emergency Medicine and Paediatrics. Further, in the examination pattern, General Medicine (and its sub-specialities like cardiology, neurology etc.) has been identified as the only feeder specialty for Critical Care Medicine. This arrangement has ruled out inclusion of MD/DNB exit level questions from Anaesthesiology, putting Anaesthesiology postgraduate students to a great disadvantage. As a result, students from Anaesthesiology are not be able to get admission in DM/DrNB Critical Care Medicine. Also, taking a note to the revised examination pattern, in which NEET SS CCM entrance examination comprise of questions from General Medicine only makes it totally biased towards one speciality despite Critical Care Medicine being the Superspeciality branch to many other specialties including Anaesthesiology.

This revised pattern of examination almost closes the avenue for the students from Anaesthesiology to take up DM/DrNB Critical Care Medicine. It is common knowledge that over 70% or more Critical Care Medicine trainees come from Anaesthesia stream. Traditionally students from General Medicine background have been opting for branches like cardiology, nephrology, gastroenterology, etc. and Critical Care Medicine remains a low priority, which can be verified from National Board of Examinations in Medical Sciences admission records of Critical Care Medicine. Under the new scheme of things, it is feared that the speciality of Critical Care Medicine may undergo an undesirable metamorphosis with significant number of seats going vacant affecting not only capacity building but also jeopardising career prospects of young anaesthesiologists.

As The Indian Society of Anaesthesiologists, we are concerned about the future of Critical Care Medicine and Anaesthesiologists in India and urge your good office to kindly consider the following options:

- 1. Reverting the examination pattern to the previous pattern or**
- 2. Creating a separate group of Critical Care and asking questions from basic critical care. Basic critical care is part of curriculum of both Medicine and Anaesthesiology.**

This will be in the interest of fair play amongst all feeder specialties in particular and Critical Care Medicine super speciality in general.

In the NEET Super Specialty (D.M/ M.Ch/ DNB SS) Examination 2022, out of around 1000 seats remaining vacant, 25% vacant seats are of Critical Care. Around 200 DrNB Critical Care Seats and 25 DM Critical Care Seats have remained vacant even after special mop up round. This is entirely due to the revised pattern of the examination of NEET Super Speciality (NEET-SS) DM/DrNB in Critical Care Medicine (CCM) where General Medicine has been identified as the only feeder specialty for Critical Care Medicine.

This arrangement has ruled out inclusion of MD/DNB exit level questions from Anaesthesiology, putting Anaesthesiology postgraduate students to a great disadvantage. As a result, students from Anaesthesiology are not be able to get admission in DM/DrNB Critical Care Medicine. Also, this revised examination pattern is totally biased towards one speciality (general medicine) despite Critical Care Medicine being the Superspeciality branch to many other specialties including Anaesthesiology.

It is an established fact that over 70% or more Critical Care Medicine trainees come from Anaesthesia stream. Traditionally students from General Medicine background have been opting for branches like cardiology, nephrology, gastroenterology, etc. and Critical Care Medicine remains a low priority. Under the new scheme of things, it is feared that the speciality of Critical Care Medicine may undergo an undesirable metamorphosis affecting not only capacity building but also jeopardising career prospects of young anaesthesiologists.

As a result of changed examination pattern, a very small number of anaesthesiology specialists could qualify for Critical Care Medicine Superspeciality course this year. Secondly and more importantly, with this pattern, as only handful of Anaesthesiology candidates could qualify, around 200 DrNB Critical Care and 25 DM Critical Care seats have remained vacant even after special mop up round. Thus, there is no point of having a pattern that leads to such large wastage of seats.

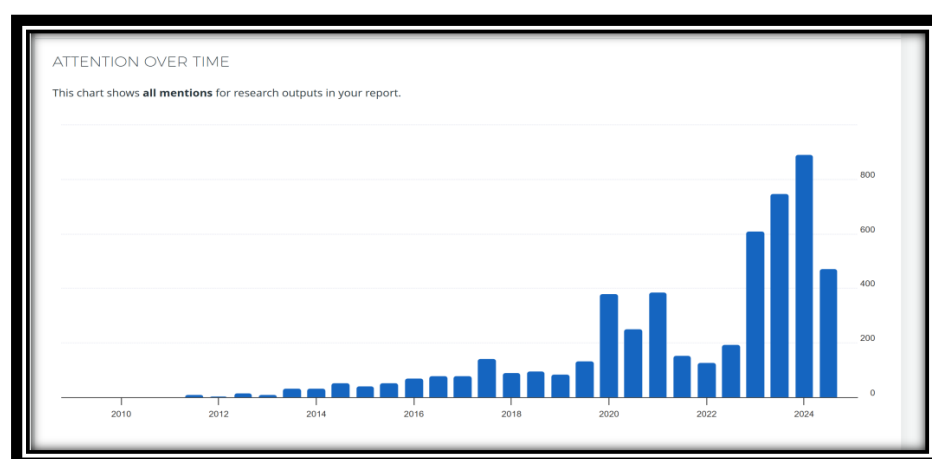
