1. Nomination/Application (signed copy) for these posts to be received from 10-06-2025 and must reach the Office of the Honorary Secretary, Indian Society of Anaesthesiologists (National) before 5:00 PM on 15-06-2025, by Registered Post with ACK due / Speed Post / Courier / **E-mail** /By hand at the Office of ISA National. A scanned copy of the nomination form should be **submitted online** / by **E Mail** also to [isanhq@gmail.com](mailto:isanhq@gmail.com) and [secretaryisanhq@gmail.com](mailto:secretaryisanhq@gmail.com). The list of all Nominations received will be published in ISA Office and ISA website on 16-06-2025. Incomplete Nominations will be rejected. The list of all valid Nominations will be published on 18-06-2025. The Candidate, Proposer and

Seconders must be Active Life Members of ISA with eligibility to vote online in their respective Zones.

2. A template will be sent to all eligible candidates on 16<sup>th</sup> June, 2025 to fill their profile (including achievements, awards, honours, experience, contributions to ISA etc.) as desired by ISA National so as to display as candidate's profile during elections and voting.
3. Last date for withdrawal of the Nomination is 21-06-2025 before 5:00 PM and the final list of eligible candidates will be published in ISA Office and ISA website on 22-06-2025.
4. Last date for Registering for Online Voting is 31-05-2025 up to 5:00 PM.
5. The final voter lists (online only) will be published in the ISA Website ([www.isaweb.in](http://www.isaweb.in)) on 15-06-2025.
6. Elections will be held online only. There will be no manual voting
7. Online voting will be open for five days, from 26.06.2025 (08:00 AM) to 30.06.2025 (05:00 PM). Real time count of voting and names of persons who have voted will be available. The final details of votes polled will be published and the result will be declared immediately after voting is closed on 30-06-2025. There will be **Pre Poll and Post Poll Audits in the same manner as was done during last year and from the same agencies** (internal and external). **One vote** can be cast from **one IP address**.
8. Eligibility criteria:
  - a) Contestant must be a continuous member of society for not less than ten years for the posts of Vice President and President Elect.
  - b) Contestant must be a continuous member of society for not less than five years for the post of Honorary Secretary, Treasurer, Editor in Chief IJA and Governing Council Member ISA.

c) Contestants for the Posts of Vice President, President Elect, Honorary Secretary and Treasurer should have served one full term of office in the Governing Council earlier.

d) Contestants should have attended three of the last five Annual General Body Meetings and must have signed in the AGBM Register.

e) For Editor in Chief of IJA, additional criteria have to be strictly followed which includes:

**ADDITIONAL CRITERIA FOR CONTESTING FOR THE POST OF EDITOR-IN-CHIEF, IJA AND OTHER JOURNALS OF THE ISA / CISA**

- *The Applicant should possess at least 10 years of experience in Anaesthesiology and be a member of the ISA for at least 5 years.*
- *Applicant should have at least 5 years of experience serving on the editorial board of a PubMed-indexed journal.*
- *Must have a minimum of 15 original articles / systematic reviews / meta-analyses in PubMed indexed anaesthesiology journals (other than Case reports, letters to the editor, short summaries, etc) or a Google Scholar H-index  $\geq 10$*
- *It is desirable that he/she should have contributed to a registered ethics committee as a member for at least two years.*
- *Must have at least one Good Clinical Practice training certificate obtained prior to applying as a candidate for election for the post of EIC*
- *A background in publishing, editing, or journalism is a must.*
- *Each applicant should provide a summary of the vision document (200 words) outlining editorial strategies for development in the next 3 years to further improve the quality of the Journal.*

f) Each nomination must be accompanied by self-attested proof of the nomination fee. The Nomination fee (**Nonrefundable**) should be in the form of NEFT / cash deposit in favour of "**Indian Society of Anaesthesiologists**" (**ISA National**) payable at SBI, Tripuri, Patiala, Punjab (Current A/c No. 35292412841, IFS Code SBIN0011586). The nomination fee for various posts is mentioned below which is **inclusive of GST**:

All Life Members of ISA as on 31.05.2025 who have registered their E-Mail ID and Mobile Number with ISA NHQ are only eligible to Vote. New Members enrolled on (after 5:00 PM) or after 31.05.2025 and old members who do not register their E Mail ID and Mobile Number with ISA NHQ will have all the privileges of his/her class of Membership, except the right to Vote in this Election.

The nomination of candidates to the election shall be made in the prescribed format, which is enclosed herewith. Every nomination together with the written consent of the candidate to contest the election duly proposed by one and seconded by another **Active ISA Life Member** shall be sent to the Honorary Secretary, ISA National so as to reach him not later than 5:00 PM on 15-06-2025.

This notification is issued as per the Memorandum of Association and By Laws of ISA for the conduct of 2025 elections and is meant for all zones, states and cities. State and City branches can hold their elections anytime till 31<sup>st</sup> July, 2025 as per the norms being followed in their respective branches.

However, handover to the next team should be done on 16<sup>th</sup> October or anytime as being practised in their respective branches. Moreover, all such information to and permission from the ISA NHQ should be sought prior to implementing such acts.

**Highest standards of our Specialty and Maintenance of integrity of ISA are expected during this election period. The elections will be conducted from ISA NHQ by employing the external agency of highest repute which will be finalized and conveyed to all ISA members before publishing the final list of eligible candidates.**

### ISA ONLINE ELECTIONS 2025

#### GENERAL GUIDELINES FOR CANDIDATES AND VOTERS

- Canvassing by personal contact, SMS, E-Mail, Telephone calls is allowed.
- Only one application form will be entertained. **If someone wishes to submit two or more application forms for the same post, that should be accompanied by the equivalent fees with each form. Only the first form will be taken as original form if other forms are sent without equivalent fees.**
- No paid bulk SMS and recorded (audio & video) phone messages are allowed (including Greetings).
- Canvassing in Social media is allowed.
- Only candidates are allowed to campaign in the social media. **No group forward is allowed by any ISA Member.**
- **No candidate should attend any ISA related event as a faculty from 10<sup>th</sup> June 2025 till 30<sup>th</sup> June, 2025.** However, they can attend these events as ordinary delegates.
- **Use of ISA logo and ISA Flag is strictly prohibited in flyers.**
- The candidates should do positive campaign and maintain the dignity of our profession and sovereignty of our constitution.
- No negative campaigning is allowed. Any negative campaigning will invite penal action from ISA National which will vary from simple warning to suspension of the candidature depending upon the degree of offence. **If proved to be true, the penal action taken will be final.**
- **Use of derogatory remarks, language or comments against other candidates is strictly prohibited.**

- Voter's list can be obtained by the candidates from ISA National Secretariat on request and it has to be used only for election purpose and not to be shared with anyone at all once the list of the candidates is finalized.
- All Life Members of ISA as on 31/05/2025 who have registered their E- Mail ID and Mobile Number with ISA NHQ only are eligible to Vote.
- New Members enrolled on or after 31/05/2025 and old members who do not register their E Mail ID and Mobile Number with ISA NHQ will have all privileges of the class of Membership, except the right to Vote in this Election.
- Request for conversion from ALM to LM can be made up to 5 PM, 31-05-2025 which was duly conveyed on ISA website and in every city and state WhatsApp group.
- Any clarification and updating can be done at ISA Secretariat with the knowledge of Secretary with proof till 5 PM, 31-05-2025
- No request for any changes will be entertained after 5 PM, 31-05-2025 for this year's elections. All such requests will be kept pending till elections are over.
- The updation process will be completed by 31<sup>st</sup> May, 2025. The final voter lists (online only) will be published in the ISA Website ([www.isaweb.in](http://www.isaweb.in)) on 15-06-2025.
- Although ISA Elections are conducted in a free, fair and smooth manner but a **caveat** shall be filed in the Local Court at ISA National Head Quarters in the name of all candidates of ISA Elections. This is necessitated to protect the interest of ISA in case any legal eventuality arises out of ISA Elections.
- Nobody (candidates/ members) is authorized to send messages in name of ISA, ISANHQ, ISAHQ. This is cyber-crime and impersonation. If any member sends such sms, he/she will be suspended from ISA Membership.
- If a non-member sends, suitable action will be taken against him/her after reporting to cyber-crime cell.
- The campaigning should stop on 25<sup>th</sup> June, 2025 by 5 PM. After that only personal calls are allowed.
- The sitting State Office bearers should not use official letterhead for campaigning.
- The ISA National Office Bearers/ Governing Council Members cannot occupy positions in state and city branches. If any candidate is occupying higher post, that person cannot vie to occupy lower post. If this is done, then that person cannot apply for 10 years for any higher post. No person can occupy two posts in any ISA Formation simultaneously whether in National, State or City executive body. In the oath form to be filled by incoming Office

Bearers / Members of the Governing Council of the ISA, it shall be mentioned that he/she solemnly swears and affirm that I am not holding any post in ISA State or City Branch.
