

FADA sets to host the 2nd edition of Vyapar in Kerala

The upcoming event will convene industry leaders, policymakers and entrepreneurs to jointly shape the future of mobility and trade in the region. The day will feature an Interactive Session with **Mr. Nagaraju Chakilam, IPS, Transport Commissioner, Govt of Kerala**, moderated by **Mr Manoj Kurup, Chairperson, FADA Kerala & Managing Partner & CEO, Radhia Motors**, where discussions will focus on improving ease of doing business for dealerships, streamlining vehicle registration and compliance systems, enhancing transport infrastructure and scaling digital governance solutions. This session aims to foster direct, solution-driven dialogue between policymakers and the dealer community, paving the way for more efficient operational and regulatory frameworks.

Following this, a high-impact **Session on the Future of Auto Dealerships in India** led by **Mr Hemal N Thakkar, Senior Practice Leader & Director, Crisil Ltd**, will examine the changing landscape of automotive retail in the country. The session will forecast the impact of digital customer journeys, EV-driven business restructuring, evolving financing formats and the need to build lean yet high-performing dealership models to sustain profitability and relevance over the next decade.

The conference will then host a **Session on How to Leverage AI in the Automotive Industry to Boost Profitability**, featuring **Mr Akhil Mathew, Business Strategist, Beegains**, and **Mr Mohammed Jabeen, AI**

Analyst, Beegains, emphasising how AI-enabled systems are set to revolutionise dealership management across customer lifecycle mapping, predictive demand planning, CRM optimisation, targeted marketing and aftersales performance.
