


# STATE-WISE COVID-19 GUIDELINES

## State-wise COVID-19 Guidelines

### Andaman & Nicobar Islands



#### Domestic

##### Institutional quarantine

All incoming passengers viz. unvaccinated, partially vaccinated (those who have taken only 1st dose of COVID vaccine), those who have taken both doses, but have not completed 15 days since the administration of 2nd dose and passengers who are found symptomatic on arrival at Port Blair irrespective of their vaccination status are tested with RT-PCR at free of cost at ITF ground and who are tested positive by RT-PCR conducted at ITF ground, will be institutional/Home quarantine as per Standard Operating Procedures (SOPs) in Government facilities or will have the option to stay in identified hotels on payment basis.

##### Home quarantine:

All incoming passengers viz. unvaccinated, partially vaccinated (those who have taken only 1st dose of COVID vaccine), those who have taken both doses, but have not completed 15 days since the administration of 2nd dose and passengers who are found symptomatic on arrival at Port Blair irrespective of their vaccination status from mainland **to undergo compulsory home quarantine or institutional quarantine until the reports of their test on arrival at Port Blair are found negative.** Any person violating the above directions shall be liable to be fined to the tune of ₹ 5000/- each time.

##### Health Screening: Not required

##### COVID test:

All asymptomatic passengers who have been vaccinated with both doses of the COVID 19 vaccine and 15 days have lapsed since the administration of second dose of the vaccine and are in possession of the final vaccination certificate issued through the COWIN portal are exempted from mandatory requirement of carrying a negative RTPCR report to travel to Port Blair from Mainland and also such passengers will be exempted from undergoing additional RTPCR test on arrival at Port Blair airport. Such passengers shall also have to produce the ID card / document mentioned in the vaccination certificate, for verification.

Passengers who are found symptomatic on arrival at Port Blair, irrespective of their vaccination status shall be subjected to RTPCR / Rapid Antigen Test at the airport terminal to aid identification.

All incoming passengers viz. unvaccinated, partially vaccinated (those who have taken only 1st dose of COVID vaccine) and those who have taken both doses, but have not completed 15 days since the administration of 2nd dose shall **MANDATORILY** carry RT- PCR negative test report issued from an ICMR approved Labs, subject to the condition that RT-PCR test should have been taken within 48 Hrs prior to commencement of journey and produce the Test Result /Report at the originating station and also at ITF ground at Port Blair for verification with SRF ID No. for validation.

In addition to the above, the RT-PCR test will be conducted on all incoming passengers viz. unvaccinated, partially vaccinated (those who have taken only 1st dose of COVID vaccine), those who have taken both doses, but have not completed 15 days since the administration of 2nd dose and passengers who are found symptomatic on arrival at Port Blair irrespective of their vaccination status at free of cost at ITF ground by transporting the passengers to the ITF ground in buses by the administration.

The report of RT-PCR conducted at ITF ground will be available via phone number provided in self-declaration form.

All incoming passengers viz. unvaccinated, partially vaccinated (those who have taken only 1st dose of COVID vaccine), those who have taken both doses, but have not completed 15 days since the administration of 2nd dose and passengers who are found symptomatic on arrival at Port Blair irrespective of their vaccination status from mainland to undergo compulsory home quarantine or institutional quarantine until the reports of their test on arrival at Port Blair are found negative.

##### If tested positive,

Positive tested passengers shall be kept under institutional/Home quarantine as per Standard Operating Procedures (SOPs) in Government facilities or will have the option to stay in identified hotels on payment basis.

Any person violating the above directions shall be liable to be fined to the tune of Rs.5000/- each time.

##### Passenger obligation:

###### Arriving Pax –

- 1) All asymptomatic passengers who have been vaccinated with both doses of the COVID 19 vaccine and 15 days have lapsed since the administration of second dose of the vaccine and are in possession of the final vaccination certificate issued through the COWIN portal are exempted from mandatory requirement of carrying a negative RTPCR report to travel to Port Blair from Mainland and also such passengers will be exempted from undergoing additional RTPCR test on arrival at Port Blair airport. Such passengers shall also have to produce the ID card / document mentioned in the vaccination certificate, for verification.
- 2) Passengers who are found symptomatic on arrival at Port Blair, irrespective of their vaccination status shall be subjected to RTPCR / Rapid Antigen Test at the airport terminal to aid identification.
- 3) All incoming passengers viz. unvaccinated, partially vaccinated (those who have taken only 1st dose of COVID vaccine) and those who have taken both doses, but have not completed 15 days since the administration of 2nd dose shall **MANDATORILY** carry RT-PCR negative test report issued from an ICMR approved Labs, subject to the condition that RT-PCR test should have been taken within 48 Hrs prior to boarding for Port Blair from mainland and produce the Test Result / Report at the originating station and also at ITF ground, Port Blair for verification with SRF ID No. for validation.
- 4) Self declaration forms to be filled by passenger which is handed over while de-boarding.
- 5) In addition to above, the RT-PCR test will be conducted at free of cost on all incoming passengers viz. unvaccinated, partially vaccinated (those who have taken only 1st dose of COVID vaccine), those who have taken both doses, but have not completed 15 days since the administration of 2nd dose and passengers who are found symptomatic on arrival at Port Blair irrespective of their vaccination status by transporting all passengers to ITF ground through buses by administration to get tested for RT-PCR.
- 6) Report of RT-PCR will be available via phone number provided in self-declaration form.
- 7) All incoming passengers from mainland undergoing RT-PCR test to undergo compulsory home quarantine or institutional quarantine until the reports of their test on arrival at Port Blair are found negative. Any person violating the above directions shall be liable to be fined to the tune of ₹ 5000/- each time.
- 8) Passenger found positive as per the test done on arrival at Port Blair shall be kept under institutional/Home quarantine as per Standard Operating Procedures (SOPs) in Government facilities or will have the option to stay in identified hotels on payment basis.
- 9) Wearing of masks is mandatory
- 10) Passengers who are not carrying proper negative RT-PCR report shall not be boarded for Port Blair flight.
- 11) All arriving passengers need to co-operate with airline staff and officials verifying the RT-PCR report at origin boarding points and performing the RT-PCR test at ITF ground.

**Departing Pax** - Passengers having safe status in the Arogya Setu app and Only those who are wearing masks are allowed to board the flight.

##### Airlines obligation:

1. To make in-flight announcements about the latest order.
2. Display Quarantine guidelines of Port Blair airport at boarding points in origin stations.
3. Self declaration forms to be handed over to Pax during deboarding and the same need to be given to doctors at ITF ground.
4. Passengers data in the given format to be shared with District Authorities as deputed by DC South Andaman at the airport.

##### Airport/State obligation:

Social distancing to be maintained between passengers.

Transporting of passengers from airport to ITF ground will be done by district authorities for conducting RT-PCR test on all incoming passengers.

Transporting positive tested passengers to IQ centers will be done by district authorities.


Provision of Facilities and infrastructure as mandated in MOCA Guidelines.

##### COVID test:

Passenger arriving at Patna Airport from any state has to undergo Rapid Antigen test upon arrival at the Airport, Facility for which has been arranged at the Airport. However such passenger who will be carrying negative RT-PCR report for covid-19 generated within 72 hour, will be exempted from undergoing the Rapid Antigen Test

###### **Gaya**

As per Home Deptt, Govt. of Bihar order No. जी /आपदा – 06-02/2020- 9388 dated 30.11.2021

RA test will be carried out for every pax. However those who produce RTPCR Negative report of within 72 Hours shall be exempted from RA TEST. These shall be effective w.e.f. 01.12.2021 .

RA test will be free of cost .

###### **Darbhanga**

72 hours before from travelling time RTPCR test for covid-19 is compulsory for Passengers who are coming from Mumbai and Chennai. From State Govt. two team deployed to check the Antigen and RTPCR test for International passengers (If any).

##### Passenger obligation:

###### **Patna/Darbhanga**

1) All passengers must download Arogya Setu App.

2) Wearing of Mask is made compulsory for entry into Terminal Building.

###### **Gaya**

Pax shall have to wear a mask properly, maintain social distancing upon arrival and follow medical team instructions.

##### Airlines obligation:

###### **Patna**

All Airlines Shall make an onboard announcement for proper disposal of PPEs in bio-hazard bins.

###### **Darbhanga**

Shall make an on-board announcement for proper disposal of PPEs in bio-hazard bins.

###### **Gaya**

The Airlines should make time to time announcement through PA system for maintaining social distancing and wearing of mask properly.

They shall also keep passengers updated regarding changing COVID-19 guidelines from time to time.

##### Airport/State obligation:

###### **Patna**

1) Thermal Screening is being carried out for every arriving passenger at the airport.

Passenger arriving at Patna Airport from any state has to undergo Rapid Antigen test upon arrival at the Airport, Facility for which has been arranged at the Airport. However such passenger who will be carrying negative RT-PCR report for covid-19 generated within 72 hour, will be exempted from undergoing the Rapid Antigen Test.

###### **Darbhanga**

1) Thermal Screening is being carried out for every arriving passenger at the airport.

2) 72 hours before from travelling time RTPCR test for covid-19 is compulsory for Passengers who are coming from Mumbai and Chennai.

###### **GAYA**

Co-ordinate with the medical team for COVID-19 test of incoming passengers.

# Chhattisgarh



### **Domestic**

**Institutional quarantine:** Not applicable

**Home quarantine:** Not applicable

**Health Screening:** All passengers travelling from other states to Chhattisgarh who have certificate for both doses of vaccination of COVID-19 are exempted from RT PCR test. Also, the mandatory negative RT PCR test report issued within 96 hours of arrival for the remaining passengers has been discontinued.

#### **COVID test:**

All passengers travelling from other states to Chhattisgarh who have certificate for both doses of vaccination of COVID-19 are exempted from RT PCR test. Also, the mandatory negative RT PCR test report issued within 96 hours of arrival for the remaining passengers has been discontinued.

#### **Passenger obligation:**

All passengers have to follow the COVID-19 regulations and protocols as decided by the Ministry of Civil Aviation while they are at the Airport.

#### **Airline obligation**

All airlines to disseminate the information regarding passenger obligation as mentioned above at the time of booking to avoid any inconvenience to passengers.

#### **Airport/State obligation:**

All passengers travelling from other states to Chhattisgarh who have certificate for both doses of vaccination of COVID-19 are exempted from RT PCR test. Also, the mandatory negative RT PCR test report issued within 96 hours of arrival for the remaining passengers has been discontinued. To ensure that all passengers are following the COVID-19 regulations and protocols as decided by the Ministry of Civil Aviation while they are at the Airport.

# Jharkhand



### Domestic

#### **Institutional quarantine:**

No institutional quarantine now. Passengers if tested positive will be sent for 14 days home Isolation or to be admitted in private/government health institution based on report by Incident Commander and Home Isolation Team to be decided at the level of Civil Surgeon Ranchi. State government may be coordinated for further details and updated guidelines.

#### **Home quarantine:**

All domestic travellers shall self-monitor their symptoms for 14 days in case of interstate travel and shall comply with the guidelines issued by MoHFW. Passengers if tested positive will be sent for 14 days home Isolation or to be admitted in private/government health institution based on report by Incident Commander and Home Isolation Team to be decided at the level of Civil Surgeon Ranchi. State government may be coordinated for further details and updated guidelines.

#### **Health Screening:**

Thermal screening will be done mandatorily for all the arrival and departure passengers.

#### **COVID test:**

All passengers coming to the state of Jharkhand need to mandatorily undergo COVID Test (Free of Cost) at Testing facility available at the Airport by the state Administration.

Those Passengers, carrying :-

- a) Negative RT-PCR report (within 72 Hrs)  
OR
- b) Fully Vaccination Certificate with both Doses as well as completed At-least 15 days shall be exempted from the latter test.

#### **Passenger obligation:**

All the passengers coming to Jharkhand from all other states shall carry RT-PCR test negative report (Within 72 hrs.) OR Fully Vaccination certificate of both doses (completed at-least 15 days) and produce the test results/report at Airport.

Passengers not carrying Negative RTPCR Report OR Fully Vaccination Certificate shall have to mandatorily go through COVID 19 Testing (Free of Cost) at Airport after submission of Self Declaration online through "JHARKHAND HOME ISOLATION MANAGEMENT SYSTEM, GOJ" web portal.

Passengers having symptoms will be sent to Govt. health facility or home isolation on the basis of self-declaration after sample collection.

#### **Airline obligation**

Airlines shall Disseminate the information for carrying -ve RTPCR Test Report OR Fully Vaccination certificate (Completed at-least 15 days) and make on-board announcement for

- a. Submission of Self Declaration Form on Arrival and
- b. Disposal of PPEs in Bio-hazard bins before leaving the Airport Terminal.

#### **Airport/State obligation:**

Setup of COVID 19 Testing facility, multiple sample collections points and a TrueNAT testing camp by State government at the Airport and its enforcement.

Thermal scanning of all the arriving and departing passengers by government health officials.

Deployment of sufficient testing, sample collection and contact tracing team by state government for any positive case detected.

# Odisha (Bhubaneswar Airport)



### **Domestic**

#### **Institutional quarantine:**

Not required to produce Rapid Antigen test/RT-PCR negative/Covid Vaccination certificate.

#### **Home quarantine:**

Not required to produce Rapid Antigen test/RT-PCR negative/Covid Vaccination certificate.

#### **Health Screening:**

Health Screening facility not available at the airport.

#### **COVID test:**

No COVID testing facility available at the airport.

#### **Passenger obligation:**

Not required to produce Rapid Antigen test/RT-PCR negative/Covid Vaccination certificate.

#### **Airline obligation**

Digital self-declaration form which is to be submitted by airlines to State Health Authority on daily basis. Airlines shall make onboard announcement for proper disposal of PPEs in Bio Hazard bins before leaving the Airport terminal.

#### **Airport/State obligation:**

COVID-19 prevention and precautionary tips are displayed in FIDs and flex banner and stickers are pasted/placed at different passenger eye contact points.



## State-wise COVID-19 Guidelines

### Odisha (Jharsuguda Airport)



#### Domestic

**Institutional quarantine:** Not required

**Home quarantine:** Not required

**Health Screening:** Health screening facility Not available at Airport.

#### COVID test:

Swab collection facility available at Airport by state government.

#### Passenger obligation:

- 1 Passengers should self-monitor their health and travel.
- 2 All passengers shall follow COVID appropriate behaviour at all times which includes use of mask/ face cover, hand hygiene and physical distancing of six feet (do gaj ki doori) as far as feasible. Masks/face covers must be worn properly to cover nose and mouth. Touching the front portion of mask/face covers to be avoided.
- 3 Avoid spitting in public places during travel.
- 4 All passengers shall be advised to download Arogya Setu app on their mobile devices.
- 5 If they develop fever during travel, they shall report to cabin crew/TTE/bus conductor as the case may be.
- 6 If they develop symptoms after reaching their final destination, they shall inform the district Surveillance Officer or the State/National Call Centre (1075).

#### State/National Call Centre (1075).

7. All travellers should a. Submit self-declaration form on the online Air Suvidha portal (<https://www.newdelhiairport.in/airsuvidha/apho-registration>) before the scheduled travel, including last 14 days travel details. b. Upload a negative COVID-19 RT-PCR report\*. This test should have been conducted within 72 hrs prior to undertaking the journey. c. Each passenger shall also submit a declaration with respect to authenticity of the report and will be liable for criminal prosecution, if found otherwise.
8. They should also give an undertaking on the portal or otherwise to Ministry of Civil Aviation, Government of India, through concerned airlines before they are allowed to undertake the journey that they would abide by the decision of the appropriate government authority to undergo home/institutional quarantine/ self-health monitoring, as warranted.
9. Continuing with the earlier approach, travellers from certain specified Countries (based on epidemiological situation of COVID-19 in those Countries) are identified for additional follow up. These include need for additional measures as detailed in para (xv) below. The listing of such specified Countries is a dynamic exercise based on evolving situation of COVID-19 across the world and will be made available on the websites of Ministry of Health & Family Welfare, (mohfw.gov.in) and the link of the same will be available at website of Ministry of External Affairs and Air Suvidha Portal.

#### Airline obligation

10. Digital self-declaration form which is to be submitted by airlines to State Health Authority on daily basis. Airlines shall make onboard announcement for proper disposal of PPEs in Bio Hazard bins before leaving the Airport terminal.
11. Passengers originating or transiting from at-risk countries shall be informed by the airlines that they will undergo post arrival testing, quarantine if tested negative, stringent isolation protocols if tested positive etc. as mentioned in para (xv). 2 v. Do's and Don'ts shall be provided along with ticket to the travellers by the airlines/agencies concerned.
12. Airlines to allow boarding by only those passengers who have filled in the Self Declaration Form on the Air Suvidha portal, uploaded the negative RT-PCR test report.
13. At the time of boarding the flight, only asymptomatic travellers will be allowed to board after thermal screening. viii. All passengers shall be advised to download Aarogya Setu app on their mobile devices.
14. In-flight announcement about COVID-19 including precautionary measures to be followed shall be made at airports and in flights and during transit. During in-flight crew shall ensure that COVID appropriate behaviour is followed at all times. If any passenger reports symptoms of COVID-19 during flight, he/she shall be isolated as per protocol.

#### Airport/State obligation:

15. COVID-19 prevention social distance to be maintained, wearing mask and precautionary tips are displayed in FIDs and flex banner and stickers are pasted/placed at different passenger eye contact points.
16. De-boarding should be done ensuring physical distancing.
17. Thermal screening would be carried out in respect of all the passengers by the health officials present at the airport. The self-declaration form filled online shall be shown to the airport health staff .
18. The passengers found to be symptomatic during screening shall be immediately isolated and taken to medical facility as per health protocol. If tested positive, their contacts shall be identified and managed as per laid down protocol.
19. Travellers from specified Countries at risk [as mentioned in para (xv)] shall be monitored.
20. Above will follow the protocol as detailed below:
  - Submission of sample for post-arrival COVID-19 test\* at the point of arrival (self-paid). Such travellers will be required to wait for their test results at the arrival airport before leaving or taking a connecting flight.
  - If tested negative they will follow, home quarantine for 7 days. Re-test on the 8th day of arrival in India\* and if negative, further self-monitor of their health for next 7 days. • However, if such travellers are tested positive, their samples should be sent for genomic testing at INSACOG laboratory network.
  - They shall be managed at separate isolation facility and treated as per laid down standard protocol including contact tracing mentioned in para (xv).
21. The contacts of such positive case should be kept under institutional quarantine or at home quarantine monitored strictly by the concerned State Government as per laid down protocol. xvi. Travelers from Countries excluding those Countries at risk, will be allowed to leave the airport and shall self-monitor their health for 14 days' post arrival.
22. sub-section (2% of the total flight passengers) shall undergo post-arrival testing at random at the airport on arrival. a. The 2% of such travellers in each flight shall be identified by the concerned airlines ('preferably' from different countries).
23. Such travellers shall be escorted by the concerned airlines/MoCA to testing area on arrival.
24. The cost of testing of such travellers shall be borne by the travellers identified for random testing themselves.
25. Laboratories shall prioritize testing of samples from such travellers.
26. If such travellers are tested positive, they shall be managed as per laid down standard protocol and samples would further send for genomic testing.
27. If travellers under home quarantine or self-health monitoring, develop signs and symptoms suggestive of COVID-19 or test positive for COVID-19 on re-testing, they will immediately self-isolate and report to their nearest health facility or call National helpline number (1075)/ State Help line Number.



- \*\* 15 days must have elapsed since completion of COVID-19 vaccination schedule
- # Contacts of the suspect case are the co-passengers seated in the same row, 3 rows in front and 3 rows behind along with identified Cabin Crew. Also, all the community contacts of those travellers who have tested positive (during home quarantine period) would be subjected to quarantine for 14 days and tested as per ICMR protocol.

Thermal screening will be done for all passengers upon arrival.

#### **COVID test:**

Covid Test facility is not available in Bagdogra Airport.

All the inbound flight passengers to State of West Bengal shall have to carry either a proof of full vaccination or a Covid negative RT-PCR report for such test conducted within 72 hours before flight departure time. (Effective from 01.11.2021)

#### **Passenger obligation:**

All the inbound flight passengers to State of West Bengal shall have to carry either a proof of full vaccination or a Covid negative RT-PCR report for such test conducted within 72 hours before flight departure time. (Effective from 01.11.2021)

#### **Airline obligation**

Negative RT-PCR report test conducted within 72 hours before flight departure time for passengers boarding from Pune, Mumbai and Chennai airports to the state of West Bengal must be verified at origin by the airline staff. (this rule effective from 08.08.2021)

Negative RT-PCR report or proof of full vaccination for passengers boarding from airports (other than above 3 airports) outside the state of West Bengal must be verified at origin by the airline staff.

#### **Airport/State obligation:**

Thermal screening and health profiling shall be done upon arrival.

Thermal screening will be done for all passengers upon arrival.

#### **COVID test:**

All inbound flight passengers coming to the state of West Bengal shall have to carry either a proof of full (double) vaccination or a Covid negative RT-PCR report for such test conducted within 72 hours before flight departure time.

#### **Passenger obligation:**

All inbound flight passengers coming to the state of West Bengal shall have to carry either a proof of full (double) vaccination or a Covid negative RT-PCR report for such test conducted within 72 hours before flight departure time.

#### **Airline obligation**

Negative RT-PCR report test conducted within 72 hours before flight departure time for passengers boarding from Pune, Mumbai and Chennai airports to the state of West Bengal must be verified at origin by the airline staff. (this rule effective from 08.08.2021)

Negative RT-PCR report or proof of full vaccination for passengers boarding from airports (other than above 3 airports) outside the state of West Bengal must be verified at origin by the airline staff.

#### **Airport/State obligation:**

Thermal screening and health profiling shall be done upon arrival.

## ARUNACHAL PRADESH

### Pasighat Airport

- Every Passenger needs to undergo RAT test on arrival however, a person possessing valid final vaccination completion certificate shall be exempted from testing at the entry point. The covid negative report will be valid only if they were tested within 72 hours of entry to the state.
- Persons entering in the state from any state or union territory possessing a negative RT-PCR/TRUNAT/ CBNAAT report.
- **If Rapid Antigen Test found positive:** treatment at CCC/ home isolation till negative for COVID-19 as per state health Dept. protocol.

### Tezu Airport

- Every Passenger needs to undergo RAT test on arrival however, a person possessing a negative RT-PCR report and Tested within 72 hrs need not to go for RAT test
- If Rapid Antigen Test found positive: treatment at CCC/ home isolation till negative for COVID-19 as per state health Dept. protocol
- Payment of ₹ 200/- for RAT and ₹ 500/- for RT-PCR test to be collected by State Health Deptt.

#### Domestic

##### Guwahati

- Passengers in possession of final COVID vaccination certificate (two doses complete) shall be exempted from on arrival testing procedures.
- Rapid Antigen as well as RT-PCR Test available. If Rapid Antigen Test (RAT) found positive, Home isolation allowed only after Local authority's permission /Hospital treatment, till negative for COVID 19.
- If the test result of the RAT test is negative, the passenger will have to undergo RT-PCR at the airport itself. The cost of the RT-PCR test (INR 250) shall be borne by the passenger which is to be collected by State Health Department.
- Passengers shall be allowed to leave the airport once the sample/swab for RT-PCR test has been collected and with the condition that he/she shall remain under home quarantine until the result is declared.
- If RT-PCR positive, Home isolation with permission/Hospital treatment, till negative for COVID 19.
- If the test result of the RT-PCR test is negative, the passenger can continue his/her activities adhering to COVID-19 Protocol and norms of the state.
- Children below 10 years of age along with double vaccinated parent(s) guardian(s) coming are exempted from the mandatory COVID-19 testing. However, voluntary paid testing for such children shall be facilitated if the parents/ guardians so desire.

##### Dibrugarh

- Passengers in possession of final COVID vaccination certificate (two doses complete) shall be exempted from on arrival testing procedures.
- Rapid Antigen as well as RT-PCR Test available. If Rapid Antigen Test (RAT) found positive, Home isolation allowed only after Local authority's permission /Hospital treatment, till negative for COVID 19.
- If the test result of the RAT test is negative, the passenger will have to undergo RT-PCR at the airport itself. The cost of the RT-PCR test (INR 250) shall be borne by the passenger which is to be collected by State Health Department.
- Passengers shall be allowed to leave the airport once the sample/swab for RT-PCR test has been collected and with the condition that he/she shall remain under home quarantine until the result is declared.
- If RT-PCR positive, Home isolation with permission/Hospital treatment, till negative for COVID 19.
- If the test result of the RT-PCR test is negative, the passenger can continue his/her activities adhering to COVID-19 Protocol and norms of the state.
- Children below 10 years of age along with double vaccinated parent(s) guardian(s) coming are exempted from the mandatory COVID-19 testing. However, voluntary paid testing for such children shall be facilitated if the parents/ guardians so desire.

##### Tezpur

- All incoming passenger with two doses of COVID vaccine are exempted from mandatory testing on arrival subject to production of vaccination certificate.
- All passengers on arrival who were not vaccinated or vaccinated with single dose or symptomatic even with two doses have to undergo mandatory Rapid Antigen / RTPCR testing as subsidies rate of ₹ 250 per test.
- If Rapid Antigen Test found positive, Home isolation allowed only after Local authority's permission /Hospital treatment, till negative for COVID 19.
- If RT-PCR positive, Home isolation/ treatment in COVID Care Centre or hospital, as per protocol.
- Children below 10 years of age with double vaccinated parents, guardians are exempted from mandatory COVID 19 tests.

##### Jorhat

- All incoming passenger with two doses of COVID vaccine are exempted from mandatory testing on arrival subject to production of vaccination certificate. All passengers on arrival who were not vaccinated or vaccinated with single dose or symptomatic even with two doses have to undergo mandatory Rapid Antigen / RTPCR testing as subsidies rate of Rs.250 per test.
- If Rapid Antigen Test found positive, Home isolation allowed only after Local authority's permission /Hospital treatment, till negative for COVID 19.
- If RT-PCR positive, Home isolation/ treatment in COVID Care Centre or hospital, as per protocol.
- Children below 10 years of age with double vaccinated parents, guardians are exempted from mandatory COVID 19 tests.

##### Lilabari

- District civil hospital is taking Rapid Antigen test at Airport.
- All incoming passengers, who have been vaccinated with two doses of COVID19 vaccines and possess such certificate, on production of the same in front of screening Authority, shall be exempted from mandatory testing on arrival at Airports.
- Passengers who are vaccinated with a single dose or not vaccinated and those who are symptomatic even with two doses of vaccination shall have to undergo mandatory RAT & RT-PCR testing at their own cost on arrival.
- Testing will be done at a subsidized rate of ₹ 250/- only per RT-PCR test shall be charged. If the RAT result is positive the passenger will send for 10 days' institutional quarantine.
- Children below 10 years of age along with double vaccinated parent(s) guardian(s) coming are exempted from the mandatory COVID-19 testing. However, voluntary paid testing for such children shall be facilitated if the parents/ guardians so desire.
- If Rapid Antigen Test found positive, Home isolation allowed only after Local authority's permission /Hospital treatment, till negative for COVID 19.

##### Silchar

- All incoming passengers, who have been vaccinated with two doses of COVID19 vaccines and possess such certificate, on production of the same in front of screening Authority, shall be exempted from mandatory testing on arrival at Airports.
- Passengers who are vaccinated with a single dose or not vaccinated and those who are symptomatic even with two doses of vaccination shall have to undergo mandatory RAT & RT-PCR testing at their own cost on arrival.
- Testing will be done at Tikal Model Hospital, for which a subsidized rate of ₹ 250/- Only per RT-PCR test shall be charged. If the RAT result is positive the passenger will send for 10 days' institutional quarantine.
- Children below 10 years of age along with double vaccinated parent(s) guardian(s) coming to Silchar are exempted from the mandatory COVID-19 testing. However, voluntary paid testing for such children shall be facilitated if the parents/ guardians so desire.
- If Rapid Antigen Test found positive, Home isolation allowed only after Local authority's permission /Hospital treatment, till negative for COVID 19.

##### RUPSI

- All passengers on arrival who were not vaccinated or vaccinated with single dose or symptomatic even with two doses have to undergo mandatory Rapid Antigen / RTPCR testing as subsidies rate of ₹ 250 per test.

- If Rapid Antigen Test found positive, Home isolation allowed only after Local authority's permission /Hospital treatment, till negative for COVID 19.

- If RT-PCR positive, Home isolation/ treatment in COVID Care Centre or hospital, as per protocol.

- All incoming passenger with two doses of COVID vaccine are exempted from mandatory testing on arrival subject to production of vaccination certificate.

- Children below 10 years of age with double vaccinated parents, guardians are exempted from mandatory COVID 19 tests.

# Manipur



### Domestic

#### MANIPUR

- To check, all the arrival passengers are coming with the Negative RT-PCR/TRUENAT/CB-NAAT COVID 19 Test Report taken within 72 hrs of arrival. State to allow only those passengers who have a negative RT-PCR/TRUENAT/ CB-NAT COVID 19 test report taken within 72 hrs from arrival in Manipur.
- Additionally person belonging to Manipur undertaking Emergency travel due to unforeseen medical or other exigencies may be exempted from possessing a COVID-19 Negative certificate at the time of entry as a special case. Such person shall be tested at Airport / Point of entry to State.
- The Test Report of Rapid Antigen Test ( RAT) declared within the past 72 hours before arrival in Manipur are also accepted.
- Fully vaccinated passengers i.e. Those who have received both doses of COVID-19 vaccine and had completed 15 days from the receipt of the 2nd dose are exempted.
- COVID Protocols will be followed for passengers testing positive.

# Meghalaya



### Domestic

## MEGHALAYA

### ENTRY AND EXIT PROTOCOL

#### 1. REGISTRATION:

It is mandatory for all persons entering Meghalaya to register themselves prior to their travel at <http://meghalayaonline.gov.in/covid/testing.htm> and to download the Arogya Setu App and the Behavioural Change Management App of Meghalaya from Google play store. However, Tourists should register on the Meghalaya portal at <https://meghalaya.gov.in> to generate the 'e-invite for Tourists'.

#### 2. TESTING:

**(a)** RT-PCR Testing at Entry Points is mandatory for all persons visiting the State if they have not been fully vaccinated (both doses) or are not in possession of a RT-PCR Negative Report that is issued by a recognised laboratory 72 hours before their arrival at the entry Point.

**(b)** Persons showing symptoms on arrival at the Entry Point will be mandatorily tested by RT-PCR.

#### 3. EXEMPTION FROM TESTING AT THE ENTRY POINTS:

**(a)** Persons with a valid final certificate of vaccination (both doses) or Negative RT-PCR Report that is issued by a recognised laboratory 72 hours before their arrival at the entry Point shall be exempted from testing.

**(b)** Government officials / Technical staff / logistics experts who are engaged to perform duties related to projects pertaining to the Health & Family Welfare, Power Department, Telecommunications and other agencies providing essential services to the State as certified by Home (Political) Department, Government of Meghalaya, shall be exempted from testing at the Entry Points on production of RT-PCR negative certificate issued 72 hours or RAT negative certificate issued 48 hours before their arrival at the entry point. However, in case such persons do not possess any of the above-mentioned negative certificates, they shall be tested by RAT at the entry point.

**(C)** All persons exempted from testing at the Entry Points are also exempted from undergoing quarantine but shall strictly adhere to the protocols.

#### 4. QUARANTINE:

**(i)** All persons tested by RT-PCR at the entry point should go into home quarantine or paid quarantine till the test results are declared. The test results are usually available within 48 hours which shall be communicated through an SMS or can be checked online at [www.coronamegh.in](http://www.coronamegh.in). If tested positive, SOP for home or institutional isolation should be followed. If tested negative, such individuals can carry on with their daily activities or work normally.

**(ii)** Persons showing symptoms on arrival at the Entry Point will have to be mandatorily tested by RT-PCR even if they belong to category 3(a) and 3(b) above. Such persons shall proceed to their residence or place of stay and shall undergo home quarantine or paid quarantine for 7 (seven) days from the date of their arrival regardless of their test results. If tested positive, SOP for home or institutional isolation should be followed.


#### 5. ADVISORY:

**i)** All persons are advised to take personal health safety measures to protect themselves, including practicing social or physical distancing, cleaning hands with soap/hand sanitizer, wearing double masks and avoiding crowded areas with poor ventilation. Individuals in public spaces without a mask may be fined for non-compliance under the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020.

**ii)** All entrants are to closely monitor their health for 10 days from the date of entry into the State. Upon development of any symptoms of COVID-19, such individuals should self-report to the nearest healthcare facility/ANM/ ASHA worker. They can also report their symptoms on 14410 - State Level COVID helpline. Entrants will be monitored on a regular basis through IVRS calls from the Health Department.

# Mizoram



### Domestic

## MIZORAM

#### Health Screening:

1. Thermal screening shall be done for all passengers.
2. All passengers with or without negative COVID report will be subjected mandatory Rapid Antigen Test upon arrival.

#### Quarantine:

All arriving passengers after undergoing RAT test on arrival shall be quarantined in a facility appointed by the Government or Deputy Commissioner and shall undergo RT-PCR/TrueNAT test after 5 days. If negative shall be released from quarantine

#### Exemptions from Quarantine and on arrival testing

Passengers looking for exemption from quarantine and on arrival testing can do so if in possession of negative RT-PCR/ True Nat/ CBNAAT, conducted from an ICMR approved lab within 72 hours of arrival into the state. RT-PCR/ True Nat/ CBNAAT timeline starts from the time of sample collection

**Or**

Be in possession of final vaccination certificate (i.e., both doses complete and should have surpassed 15 days from the receipt of the 2nd dose)

**Or**

Be in possession of Certificate of discharge from Home Isolation or Covid care facility issued by the competent authority within 3 months prior to the date of entry into the state

#### Passenger Obligation:

1. All passengers must download Aarogya Setu App
2. All passengers must obtain m-Pass from [mcovid19.mizoram.gov.in](http://mcovid19.mizoram.gov.in) or mCovid19 App

#### Airlines Obligation:

1. Must ensure all passengers must obtain m-Pass from [mcovid19.mizoram.gov.in](http://mcovid19.mizoram.gov.in) or mCovid19 App without which passenger shall not be allowed to travel from origin stations

#### Airport/State Obligation:

1. Thermal screening shall be done for all passengers.
2. Rapid Antigen Test for passengers on arrival.

# Nagaland



### Domestic

#### NAGALAND

- All passengers are required to produce negative Covid 19 test report of RT PCR/TrueNAT/CBNAAT done not earlier than 72 hours prior to entry or provisional certificate of COVID-19 vaccination 1st dose and 15 days should have passed after taking the first dose or complete vaccination certificate (both the doses should have been taken).
- Resident of any NE state who is arriving in Nagaland and is a transit passenger and directly travelling onwards to any North East should have Negative COVID-19 report or vaccination completion certificate or provisional certificate of COVID-19 vaccination 1st dose and 15 days should have passed after taking the first dose and also satisfy the SOP of final destination state.
- For dignitaries and senior Govt officials entering the state, the Home Dept will provide necessary facilitation and make arrangement as the case may be.
- In case of officers/staff/personnel of military/paramilitary entering the state, the respective unit will make arrangement at POE for transportation to respective unit.
- Payment as per Govt. approved rate will be collected by Department of Health and Family Welfare, Govt. of Nagaland for RT-PCR testing

# Tripura

#### Tripura

- Both Rapid Antigen Test & RT-PCR available.
- Compulsory test will be done for all incoming passengers not carrying valid negative test reports for COVID-19 on arrival (done by RT-PCR/True NAT/CBNAAT of 48 hours) prior to journey date.
- Passengers without valid “Negative Test report” for COVID-19 done by RTPCR/True NAT/CB NAAT of 48 hours prior to journey from the following states of the country namely: Kerala, Himachal Pradesh, Sikkim, Manipur, West Bengal, Mizoram, Meghalaya, Arunachal Pradesh and Nagaland irrespective of COVID-19 Vaccination status (even if double vaccinated) will undergo compulsory test on arrival.
- However, Passengers having double vaccination certificate of more than 15 days coming from different states of the country except for those coming from the above exception states will be exempted from undergoing the test on arrival.
- Those with valid negative RTPCR test reports (done by RT-PCR/True NAT/CBNAAT of 48 hours) will be exempted from undergoing COVID tests at the Airport on arrival.
- All tests are done free of cost by the State Health Department, Govt. of Tripura.
- If, Tested positive, 14 days of mandatory quarantine and treatment as per the State Govt protocol.
- Self-isolation/ Quarantine/ Self-health monitoring for 14 days in other cases.

**Institutional quarantine:** No quarantine

**Home quarantine:** No quarantine

**Health screening:** Thermal screening will be done for all passengers on arrival.

**COVID test:** No Covid Test

#### **Passenger obligation:**

- Passengers travelling by air shall be mandatorily required to be fully vaccinated, or COVID recovered, or with negative RTPCR report of last 72 hours. As such, it is compulsory for all passengers entering Punjab to carry either a certificate of complete vaccination of both doses, or, carry a negative RT-PCR Certificate of last 72 hours. Further, in the absence of the requirements as stated, passengers would be stopped from boarding the aircraft at the point of origin itself. Children below 10 years of age are exempted from either of the conditions.
- All incoming passengers belonging to Punjab/whose destination is Punjab shall install COVA-application on their smart phone before exiting the airport. Passengers shall necessarily turn on blue-tooth and GPS.

#### **Airlines obligation:**

- Passengers travelling by air shall be mandatorily required to be fully vaccinated, or COVID recovered, or with negative RTPCR report of last 72 hours. As such, it is compulsory for all passengers entering Punjab to carry either a certificate of complete vaccination of both doses, or, carry a negative RT-PCR Certificate of last 72 hours. Further, in the absence of the requirements as stated, passengers would be stopped from boarding the aircraft at the point of origin itself. Children below 10 years of age are exempted from either of the conditions.
- The Station Managers of Airlines shall give wide publicity of these instructions and ensure that passengers who do not meet these requirements are not allowed to board at the point(s) of Origin.
- The airlines shall publicize above extensively to ensure that this information is available to all pax boarding the flights well before their departure.

#### **Airport/State obligation:**

- Passengers travelling by air shall be mandatorily required to be fully vaccinated, or COVID recovered, or with negative RTPCR report of last 72 hours. As such, it is compulsory for all passengers entering Punjab to carry either a certificate of complete vaccination of both doses, or, carry a negative RT-PCR Certificate of last 72 hours. Further, in the absence of the requirements as stated, passengers would be stopped from boarding the aircraft at the point of origin itself. Children below 10 years of age are exempted from either of the conditions.
- The passengers found to be symptomatic during screening shall be isolated and immediate action shall be taken as per health protocol.



#### Home quarantine:

• All Air passengers who have a valid contactable mobile number with the AarogyaSetu application downloaded on their phones shall be sent for Home Quarantine for 14 days or till their test results are reported negative, after their sampling is done as per the protocol in use.

• In case of Air passengers without a valid contactable phone number with the AarogyaSetu app downloaded on their phones, they will be sent to Administrative/Institutional Quarantine or Paid Quarantine for 14 days or till their test results are reported negative, in which case they are released for Home Quarantine.

• In the event of any such Air passengers testing positive, the protocol with regard to COVID-19 positive patients will be followed.

• The personnel of Defense and Central Armed Police Forces returning to duty, including transit labour hired by BRO to go to Ladakh, are exempted from compulsory 100% COVID-19 antigen testing and administrative/ institutional quarantine in any facility authorized by the Government of Jammu & Kashmir. The said personnel shall be allowed to proceed to the institutional quarantine of their respective Units/Formations for necessary quarantine as per their internal procedures.

#### Health screening:

• The following categories of incoming air passengers to the UT of J&K shall NOT be required to undergo RTPCR or Rapid Antigen Covid-19 on arrival :

a. If they are carrying a valid and verifiable Final Certificate Report of Covid-19 Test on arrival.

b. If they are carrying a valid and verifiable RT-PCR Covid-19 Negative report taken within 72 hours of arrival time.

#### COVID test:

• Concerned District Magistrates shall strictly ensure compliance to the above.

#### Airlines obligation:

• The following categories of incoming air passengers to the UT of J&K shall NOT be required to undergo RTPCR or Rapid Antigen Covid-19 on arrival :

a. If they are carrying a valid and verifiable Final Certificate Report of Covid-19 Test on arrival.

b. If they are carrying a valid and verifiable RT-PCR Covid-19 Negative report taken within 72 hours of arrival time.

• Inform passengers that there will be mandatory tests on arrival for all Passengers except for Defense Personnel and Central Armed Police Forces.

#### Airport/State obligation:

• All Passengers arriving shall be 100% tested for COVID 19 antigen using the RT-PCR or Rapid Antigen test or any other prescribed method free of Cost.

• Fulfill quarantine requirements.

• The following categories of incoming air passengers to the UT of J&K shall NOT be required to undergo RTPCR or Rapid Antigen Covid-19 on arrival :

a. If they are carrying a valid and verifiable Final Certificate Report of Covid-19 Test on arrival.



For the employees, it shall be done by respective offices / companies / firms. At the end of 5 days, they shall be tested by RT-PCR.

B. Arrivals from Kerala other than students and employees should produce the RT-PCR negative Test report and should be in Home Quarantine for 5 days.

C. Exemptions from Quarantine are as follows:

1. Constitutional functionaries, health care professionals and their spouses.
2. Children below 2 years.
3. In dire emergency situations (death in the family, medical treatment etc.)
4. Passengers in transit from and to Kerala via any mode of transport.

(II) Persons entering in Goa for Medical Emergencies on production of proof thereof.

(III) Asymptomatic passengers who are fully vaccinated possessing a vaccination certificate of both doses of Covid-19 Vaccine issued through the COWIN portal, provided, 15 days have elapsed since the administration of the second dose of such Vaccine."

**Passenger obligation:** All passengers must submit self-declaration form on Airlines website.

**Airline obligation:** Airlines shall check for Covid negative test report/Full Vaccination Certificate or any other as per Goa State Govt. guidelines prior to check-in/boarding and passengers are allowed to Board only when they possess the same. If the passenger is found symptomatic upon arrival, airline to guide customer along with their bags to the Triage room in coordination with State health Authorities.

**Airport or state obligation:** Thermal Screening upon arrival carried out by State Govt. & Checking for Covid negative test report/ Full vaccination report or any other upon arrival from all the passengers as per State Govt. guidelines.



Passenger obligation "Bhopal, Indore, Jabalpur-Passenger is required to undergo Thermal screening and health profiling at the Airport. All passengers must download Aarogya Setu App, if Aarogya Setu App is not available then self-declaration form has to be filled up by the passenger.

**Covid test:** Aurangabad, Jalgaon, Kolhapur, Mumbai, Nagpur, Nasik, Nanded, Pune, Shirdi - As per the Government of Maharashtra Notification dated 02-12-2021, all Domestic passengers arriving maharashtra who are not fully vaccinated are compulsorily to carry Negative RTPCR Test result within 72 hours before boarding.

RT-PCR test is done free of cost at Aurangabad and Nanded airport by the respective Municipal Corporation. The cost of RT- PCR test done at airport at Mumbai, Nagpur, Pune and Shirdi has to borne by passengers. RT-PCR test facility is not available at Jalgaon, Kolhapur and Nasik airport.

As per the Government of Maharashtra Notification dated 27-11-2021, Any person having a medical condition that do not allow him or her to take the vaccine and has a certificate to that extent from a recognised Doctor or a person who is less than 18 years of age.

**Passenger obligation:** Aurangabad, Jalgaon, Kolhapur, Mumbai, Nagpur, Nasik, Nanded, Pune, Shirdi - All passengers must download Aarogya Setu App and furnish Health Declaration.

**Airline obligation:** "Aurangabad, Jalgaon, Kolhapur, Nagpur, Nasik, Pune, Shirdi- Arriving passengers details with name, mobile number, residential address etc.to be shared with State Nodal officer. If passenger found symptomatic upon arrival, airline will guide passenger along with their bags to the dedicated medical room

Mumbai- To check all passengers arriving from any State to Mumbai who are carrying 72 hours prior RT-PCR Negative test report with them OR having certificate of fully vaccinated. Airline to comply with dedicated deployment of senior officials and other assisting staff 24x7 for COVID operations.

Nanded- Detailed list of arriving passengers, residential address to be shared with Nodal Officer. If passenger found symptomatic upon arrival, Medical team of Municipal Corporation will guide the pax about the further procedure.

Shirdi- Detailed list of arriving passengers with arrival flight, time, mobile number and residential address to be shared with Nodal officer. If passenger found symptomatic upon arrival, airline shall handover the passenger to the Medical team for quarantine at passengers cost. "

**Airport or state obligation:** Aurangabad, Jalgaon, Kolhapur, Mumbai, Nagpur, Nasik, Nanded, Pune, Shirdi- Thermal screening shall be done for all passengers. RT-PCR Testing Facility available at Airport for passengers except at Jalgaon and Kolhapur airport.

**Institutional quarantine:** Mumbai, Nagpur, Pune - As per SOP below

**Home quarantine:** Mumbai, Nagpur, Pune - As per MoHFW guidelines for International Arrivals dt. 30.11.2021 and Government of Maharashtra Order dated 02-12-2021.

**Health screening:** Mumbai, Nagpur, Pune - Thermal Screening upon arrival is carried out by APHO. Self Declaration form filled online to be shown to the Airport Health staff by the passengers.

**Covid test:** Mumbai, Nagpur, Pune - As per MoHFW guidelines for International Arrivals dt. 30.11.2021 and Government of Maharashtra Order dated 02.12.2021 to be followed.

As per the Govt. of Maharashtra Order dated 02.12.2021, in addition to MoHFW guidelines issued, the following categories of air passengers shall be declared as "HIGH RISK AIR PASSENGERS" i.e. (i) Passengers arriving from HIGH RISK COUNTRIES namely South Africa, Botswana and Zimbabwe. (ii) Air passengers who have visited any of these High Risk Countries" in past 15 days before arrival in Maharashtra. The restrictions apply to these passengers in addition to those imposed by GOI are : High Risk Air Passengers may be deplaned on priority and separate counters will be arranged by respective airport management Authorities at all International airports in State of Maharashtra for their screening and verification. Such all High Risk passengers shall have to undergo RTPCR test immediately on arrival at respective International airport and shall undergo mandatory 7 day 'Institutional Quarantine' with second RTPCR test to be carried out on 7th day. If any of the test is found to be positive, then the passenger will be shifted to hospital. In case 7th day RTPCR test comes negative, such High Risk Passengers will have to undergo a further 7 days of home quarantine. As per MoHFW guidelines for International Arrivals dt. 30.11.2021. **Passenger obligation:** Mumbai, Nagpur, Pune - Passenger shall board the flight with negative RT-PCR report for the test conducted within 72 hrs prior to undertaking the journey. Passengers shall submit self-declaration form and also submit declaration with respect to authenticity of the report on online Air Suvidha Portal as per MoHFW guidelines for International Arrivals dt. 30.11.2021. They shall also give an undertaking on the portal or otherwise to Ministry of Civil Aviation, Government of India, through concerned airlines before they are allowed to undertake the journey that they would abide by the decision of the appropriate Government Authority to undergo home/ institutional quarantine/ self health monitoring, as warranted.

**Mumbai, Pune, Nagpur** - Passengers to strictly abide the guidelines issued by MoHFW guidelines dated 30-11-2021 and Government of Maharashtra order dated 02-12-2021.

**Airline obligation:** Airlines to ensure availability of negative RT-PCR report before allowing the travellers to board.

The passenger found symptomatic during screening shall be immediately isolated and taken to medical facility as per health protocol. If tested positive, their contacts shall be identified and managed as per laid down protocol.

Contacts of the suspect case are the co passengers seated in the same row, 3 rows in front and 3 rows behind along with identified cabin crew. These details to be shared with State Authorities.

As per MoHFW guidelines for International Arrivals dt. 30.11.2021. Travellers from Non risk countries A sub section ( 2% of the total flight passengers) in each flight shall be identified by concerned airlines (preferably from different countries) shall undergo post arrival testing at random at the airport on arrival. The cost of their test will be borne by travellers themselves. If these travellers tested positive, they shall be managed as per laid down standard protocols.

**Mumbai** - Airlines to allow boarding only to those passengers who have filled in the Self Declaration Form on the Air Suvidha portal and uploaded the negative RT-PCR test report. At the time of boarding the flight, only asymptomatic travellers will be allowed to board after thermal screening. All passengers shall be advised to download Aarogya Setu app on their mobile devices. During boarding all possible measures for physical distancing are to be ensured. Suitable announcement about COVID-19 including precautionary measures to be followed shall be made at airports and in flights and during transit. While on board the flight, required precautions such as wearing of masks, environmental hygiene, respiratory hygiene, hand hygiene etc. are to be observed by airline staff, crew and all passengers. De-boarding should be done ensuring physical distancing.

**Airport or state obligation:** Mumbai, Nagpur, Pune - As per MoHFW guidelines for International Arrivals dt. 30.11.2021 and as per GoM Order dated 02-21-2021.

**Mumbai** - Adequate arrangements for passengers waiting for their confirmatory molecular test as well as test results, duly following social distancing and provision of temporary Isolation area for passenger testing positive. Ensure seamless sampling, testing, and waiting arrangements.

Provision of well-defined flow for arriving International passengers leading to the waiting area, ensuring Social Distancing, frequent Sanitisation and announcements.
