- 1) Whereas Recovery Certificate No. 7320 of 2023 dated November 03, 2023 was drawn against Jatin Ahuja [Defaulter] PAN: AGDPA4644F for sum of Rs. 5,21,000/- (Rupees Five Lakh Twenty-One Thousand Only) along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum, for non-payment of penalty imposed by AO vide Order No. Order/GR/PU/2023-24/28844 dated August 22, 2023 in the matter of Trading in Illiquid Stock Options on BSE.
- 2) And whereas, Notices of Attachment vide AP nos. 15083 & 15084 dated December 17, 2025 were issued attaching bank/post office accounts/lockers, demat accounts and mutual fund folios of the Defaulter;
- 3) And whereas SEBI has recovered the amount of Rs. 6,46,000/- (Rupees Six Lac Forty Six Thousand Only) from the defaulter as was due in December 2025.
- 4) In view of the above, you are hereby directed to release bank accounts/lockers, demat accounts and Mutual Fund Folio etc. of Jatin Ahuja (PAN: AGDPA4644F) attached, if any, pursuant to the above notices of attachment with immediate effect.
- 5) This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
